### MDO@OAKWOOD PRESCHOOL PROGRAM

#### **ENROLLMENT**

Our enrollment is limited to provide a good student to teacher ratio. We stay below the state guidelines for all ages. Child's age as of September 1<sup>st</sup> determines class placement. MDO@Oakwood is open to any child regardless of race, religion, gender, or special needs (if we can accommodate). Registration will be held in January and February each year. However, a two-week period for adjustments is allowed in the fall for any changes that may need to be made.

### **TUITION**

Tuition is set annually. Fees are used to provide curriculum, supplies, utilities, janitorial services, and staff, security and teachers' salaries. A non-refundable registration fee is collected at the time of enrollment. Each month's tuition is due by the 10<sup>th</sup> of each month. Enrollment of a child obligates the parents to pay for the period specified (September – May) unless there is a bona fide reason for withdrawal. You are technically paying per day. Some months are longer and some shorter, but we take an average and charge that same average amount no matter how many days there are in each month. If we miss a day that is included in that average (i.e. bad weather day), you will receive a refund/credit for that date.

# No tuition will be prorated for any reason.

We also accept cash. Credit cards will be accepted online only and will be charged a 3% convenience fee. Any payment received after the 10<sup>th</sup> of the month will result in an automatic \$20.00 late fee. Non-payment or partial payment of all fees and late charges by the 15<sup>th</sup> day of the month and/or checks returned for insufficient funds will require mandatory, immediate withdrawal of your child (ren) from the MDO program.

# HOURS OF OPERATION

Preschool classes are held from 9:00 am-2:30 pm each Tuesday and Thursday. Please do not bring your child earlier than the scheduled time. Promptness is encouraged as your child may miss an important learning opportunity involving the entire class. Also, <u>late pick-up fees begin at 2:35 pm</u>. A late fee of \$20.00 will be charged for each 15-minute segment that a child remains in the care of MDO teachers or staff.



### SCHOOL CALENDAR

MDO will basically follow the N.B.I.S.D. calendar. A general calendar for the year will be included in your beginning-of-the-year packet.

A calendar prepared by your child's teacher, specifically for your child's age group will be sent home monthly. Please note all special information and place it in a prominent area of your home so that you can refer to it often.

#### **INCLEMENT WEATHER**

MDO will not hold classes if the weather closes the **N.B.I.S.D.** school district. Please refer to the local news for bulletins. You can also check Class DoJo.

#### **CURRICULUM**

MDO@Oakwood follows a differentiated- literacy based instruction with an emphasis on biblical principles. Your child will receive a monthly calendar informing you of the instructional information planned. It is our goal to provide a variety of interactive learning experiences based on age appropriateness, interest, and abilities of the children. Included in each week's activities will be Bible stories, music, pictures, puzzles, painting, free drawing, games, dramatic play, outdoor play, and Children's Church.

# ARRIVAL AND DEPARTURE

Arrival: For the safety of the children, they must be taken by parent/guardian to the classroom and left in the care of the teacher. Please drop your child off without going into the classroom. If you want to visit with other parents, please do so in the hallway or parking lot. If you need to have a conference with the teacher, please call and set up a conference time. We feel this will cut down on confusion and separation problems that some children experience. Also, children must be picked up inside the building by a parent or other ADULT designated by the parents.

Pick Up Time: Please make sure that the person picking up your child is noted on the authorization sheet provided by the office. In the event your child is going home with someone not noted on the sheet, a written note must be given to the teacher or office in advance of the pick-up. Persons unknown to the staff must present a picture ID prior to a child being released, even with a written authorization. Safety is of the utmost importance.

#### PICKING CHILD UP EARLY

If you need to pick your child up early, he/she must be picked up from the classroom. Our staff stays very active throughout the day (in and out of the office), so children may not wait in the office for parent to show up if a parent is coming early. If you do not want your child to lay on their mat, they must be picked up prior to the time the class lays down.

#### **IMMUNIZATION RECORDS**

We are required by law to have on file for each child a validated immunization record or the required state waiver. THESE RECORDS MUST BE UPDATED ANNUALLY AND KEPT CURRENT AS IMMUNIZATIONS ARE REQUIRED BY AGE. Please contact the director about a delayed schedule or waiver information.

### PERSONAL BELONGINGS

Please discourage your child from bringing extra items unless it is Show and Tell Day. We are not responsible for lost or broken items.

# **CLOTHING**

Your child should be dressed in comfortable play clothes appropriate for the season. We recommend all children wear tennis shoes on most days. Again, safety is our concern. Boots can be dangerous in groups and leather soled shoes may cause slips and falls on the playground equipment. The children will be going outside daily. Please mark coats, gloves, hats, etc. with your child's name. Also, please send a complete set of extra clothing in a baggie marked with your child's name in the event your child should have an accident during the day. Don't forget to change out the clothing as the seasons change.

# **POTTY TRAINING**

While we will gladly assist with potty training as much as possible, we do require that your child wear "PULL UPS" during the potty-training process. (Thank you for your cooperation in this matter!) All students in the three and four-year-old classes MUST be potty trained.

# **PLAYGROUND**

The teachers will be on duty when the children are scheduled to be on the playground. Every effort will be made to protect children while they are outside. If the weather permits, we will go outside everyday. On cold or chilly days, please dress your child in appropriate clothing (coats, jackets, or sweaters).

#### **ILLNESS**

If your child is ill with a communicable disease, please let us know as we must notify other parents. If your child becomes ill at school, you will be notified immediately and will be expected to come and get your child. If you cannot be reached, authorized emergency persons will be contacted to pick up the child. We did not have a sick room. Please do not send your child to school if he/she is ill. If you are called to pick your child up from the office, he/she must be picked up within 30 minutes of being called. Any child not picked up within that time limit will result in a \$20 late fee.

Children will not be allowed to participate in our program if any of the following conditions exist:

- 1. Temperatures of 100 and above.
- 2. Skin rash other than a localized diaper rash
- 3. Heavy or discolored nasal discharge
- 4. Vomiting or diarrhea
- 5. Constant or severe cough
- 6. Evidence of lice infestation
- 7. Any suspected contagious or severe illness (i.e., strep throat, conjunctivitis (pinkeye), chicken pox, impetigo, etc.)
- 8. Diagnosis of a communicable disease or
- 9. General illness which prevents normal participation in activities.

Please make sure your child is free of their illness and/or fever and/or diarrhea for **24 hours** before returning to school. A doctor's note may be required.

# STUDENTS WITH SPECIAL NEEDS

While we strive to be inclusive of all children, including those with special needs, our program is not equipped to provide for every situation of children with special needs. If your child is not independent according to their biological age and needs extra help in the classroom, we may not be able to accommodate him/her. If your child has special needs, please speak to the director BEFORE registering to determine if our program is the right fit for him/her.

If it is determined that your child has needs beyond what we are able to provide, you may be asked to meet with the director to discuss options for remaining in the Mother's Day Out program. We strive to meet all children where they are, but MDO is not always a good fit for every single child.

#### **MEDICATIONS**

All teachers of MDO@OAKWOOD are certified in CPR. A first aid kit is available for any minor need. WE CANNOT ADMINISTER OVER THE COUNTER MEDICATIONS TO YOUR CHILD FOR ANY REASON.

In the event of a serious injury or medical emergency, we will make an immediate attempt to contact you and emergency contact numbers, in that order. If necessary, the child will be transported by ambulance to the nearest hospital emergency room and will be accompanied by a staff member. Until the arrival of a parent, the physician or paramedic, the Director, or Assistant Director of MDO will be in charge and make all decisions about the care of the child. Therefore, it is very important that you keep the list of emergency contacts with their phone numbers up to date.

### DISCIPLINE POLICY

A desirable climate for learning and growth is usually the result of careful planning by the staff. Discipline and guidance, therefore, shall, to the best of our ability, be consistent, be based on an understanding of the child's needs and development, and promote self-discipline and be directed toward teaching the child acceptable behavior. \* See SPECIAL NEEDS.

Harsh or physical punishment shall not be permitted. Any discipline problem shall be handled on an individual basis, with all unusual discipline problems being brought to the immediate attention of the Director. It is our desire and goal to aid your child in developing his/her potential within a Christian atmosphere. In all cases, discipline shall be corrective rather than punitive, and administered with a caring attitude.

\* At MDO @ Oakwood, our primary goal is to show God's love to all children and their families. This includes correction in a loving way. All children will be met with the same basic expectations when it comes to behavior in the classroom and beyond. If at any point a child is disruptive, we will take appropriate, loving, corrective action. If the child continues to be disruptive, they will not be allowed to remain at school that day. A parent/guardian will be called and they must be picked up right away. If you are called to pick your child up from the office, he/she must be picked up within 30 minutes of being called. Any child not picked up within that time limit will result in a \$20 late fee.

If a discipline issue has become repetitive and is not successfully corrected by disciplinary actions taken both at home as well as at MDO @ Oakwood, you will be asked to meet with the Director of MDO to discuss options for your child remaining a part of the Mother's Day Out program at Oakwood. This may include the necessary removal of your child from the program. The decision to remove a child from the program will be at the discretion of the Director.

# **RELIGIOUS TRAINING**

A Children's Church service will be held monthly. The children will become familiar with the church setting and religious symbols. Bible stories and religious songs will also be part of the weekly curriculum. The teachers will be at liberty to bring God and Jesus into any everyday situation.

Holidays, such as Christmas and Easter, will also be viewed from a biblical perspective.

#### **BIRTHDAYS**

Birthdays may be celebrated at school. Snacks for each child in the class may be furnished by the birthday child. Please speak to the teacher about planning the special snack. A sign-up sheet for parents to volunteer to bring drinks and snacks will be posted by each teacher.

Invitations may be handed out at school by the teacher, provided that every child receives one. Please understand that even small children can be very perceptive and very sensitive!

# **SNACKS/LUNCH**

We will provide a mid-morning snack each day. This should not be viewed as an alternative to a healthy breakfast. Let your child's teacher know if he/she has any food allergies. Children are not forced to eat snacks, only offered.

We do not have the staff or the facilities to provide hot meals for the children. Therefore, children will need to bring a sack lunch with them each day. <u>DO NOT BRING ITEMS THAT REQUIRE REFEGERATION.</u> Freezer packs usually do the job. Please do not send lunches that need to be heated up. Teachers do not have time to heat up lunches. Lunch bags should be labeled with the child's name and placed in the basket located outside of their classroom door each morning. Lunch will be served at approximately 12:00 noon each day.

#### **FOOD ALLERGIES**

Due to the increasing number of food allergies of our children, we are asking if your child has any severe food allergies that you send all your child's food. We do not want to take a chance of giving your child anything that might be an allergy trigger for him/her. During parties or special events, you may work with your child's teacher for main dishes but due to parents bringing items for parties, we would ask that you supply all food for your child, including snacks and sides for parties. If you have any questions about this policy, please feel free to contact the director.

### **REST TIME**

Each child is asked to bring a mat for rest time. Rest time for the older group is 45 minutes to one hour and follows lunch and outside play. Rest time for younger children is approximately 1 ½ hours and follows lunch. Please remember that each of our days is very active, and a child needs this time to rest. No child is forced to sleep, but all children must rest on their mat. Music or a story tape will be played during rest time. We try to make this a positive experience. Please help us by explaining the need for this rest period to your child. Any child who falls into a routine of disruption during nap time will be sent home for the day. If disruptive rest time behavior continues, your child will not be able to stay. He/she will need to be picked up prior to rest time. (Actual time of day will vary from class to class.)

# FIRE DRILLS

To comply with state regulations, our facility is equipped with smoke detectors and fire extinguishers in each classroom being utilized by the MDO program. Fire drills will be held twice a year. The drills will be explained to the children and are not meant to frighten them. The children will leave their rooms in an orderly fashion and assemble in a safe area away from the building.

# **EVACUTION PLANS**

Should the children's building need to be evacuated for any reason, the children will walk to a safe area away from the building.

#### LOCK DOWN DRILLS

All teachers will be trained in lock down drills in case of a security event. We keep all outside doors and hall doors locked during the school day for security reasons. If you have any questions about these procedures, please feel free to contact the Director.

### PERSONAL INFORMATION CHANGES

Please notify the staff immediately of any change of address, phone number, or family situation.

# **BACKPACKS/TOTE BAGS**

Each child needs to bring a backpack or tote bag to school daily. Teachers will place all artwork and papers in the backpack. Items brought to school, such as Show and Tell items and sleeping items, should be small enough to fit into the backpack. Storage space is minimal due to the number of ministries that use the classrooms.

Please check your child's backpack/folder daily.

### TODDLER/'BABY ROOMS

The toddler classes and baby class will not follow a specific schedule other than that created by the needs of the children. Our endeavor will be to provide a safe, nurturing, and healthy environment where each child can grow and develop through exploration of their surroundings and experimentation. Our teachers will be aware of individual needs for sleeping and eating through observation and daily communication with parents. Children will be stimulated through stories, music, toys, and games, which are age-appropriate and aimed at sensory and motor development.

# 2'S AND OLDER

Classroom teachers will create daily lesson plans based on a monthly theme and will include activities centering on biblical principles, language, science, math, social skills, music, art, and large and small motor development. Children will be offered a program rich in assorted activities in order to provide them with the opportunity to make choices. Activities will be age-appropriate within a consistent and predictable schedule. Teachers will be flexible with constant evaluation and adjustment to ensure each child's successful spiritual and educational experience.
