Homeowner Seeks Support for Traffic Calming on Leewood Dr.

With increased traffic on Franconia Road and Telegraph Road, more drivers are using Rose Hill streets to avoid traffic lights on Franconia Road at Rose Hill Drive and Telegraph Road at Rose Hill Drive.

Community efforts have been made in the past to limit cut-through traffic on Leewood Drive. One homeowner there is willing to try again. Jessie Burdick is concerned about speeding cars, reckless driving caused by drivers hurrying to circumvent the traffic light and is willing to take the time to try to do something about it. Fairfax County has a program called Residential Abatement Traffic Program that addresses traffic calming. It involves a survey of neighbors on Leewood.

will be at the August 26, 2025, meeting to make the motion. Once it is seconded and approved, RHCA will notify Franconia District Supervisor Rodney Lusk to tell the County transportation staff to begin the process. Jessie needs a signed petition from at least 10 of her neighbors to begin the process of choosing from several choices to better control traffic.

From there, the process becomes more difficult as more support is needed for more restrictive forms of traffic calming. Speed humps, for example, require approval of 50 percent of the residents who live on the street.

In the case of Cottonwood Drive between Rose Hill Drive and Telegraph via Split Rock, one speed hump on Cottonwood Drive

was approved after a long process. It has turned out, in the minds of some, not to be enough of a deterrent to limit cut-through traffic. — Carl Sell

To get the process started, we need a request from RHCA to Supervisor Rodney Lusk to that effect. Jessie

Lowery's appointment as police commander, the fourth in the last four years, continues a pattern of Fairfax County Police using the position to develop leadership talent. Lowery takes the place of Major Marisa Kuhar, who took the job a year ago and now is moving on to serve as Deputy Chief of Patrol Bureau 1.

After his initial service as a neighborhood patrol officer in Franconia, Lowery moved to the McLean District Station where he led a neighborhood patrol unit before assuming the role of

community outreach and volunteer coordinator for the Chief of Police. He served as assistant commander of the Internal Affairs Bureau's Compliance Division at the Fair Oaks District Station and was assistant commander for Search and Rescue.

A graduate of Virginia Tech, Lowery has completed leadership programs with the Fairfax County Police Department and the International Association of Chiefs of Police. Lowery assumed his new post on July 26. – Daniel Bearth

Residents Beware: Door-to-Door Solicitors Could Be Scammers

Dear Neighbors,

I want to alert everyone in the Rose Hill community about a troubling incident that recently occurred involving one of our neighbors. A company came to her door offering driveway resealing services. She agreed to the work and paid them, but unfortunately, the job was poorly done—and they charged her an outrageous amount. It turns out the company was running a scam.

Even more concerning, shortly after that incident, someone else—apparently connected to the same group—returned to her home. This time, they claimed to be from the power company, saying her entire house needed to be rewired and that a new electrical panel had to be installed. They convinced her to pay a deposit and sign a contract. As many of you know, the power company does *not* offer these types of services. It was clearly an attempt to take advantage of a vulnerable, elderly resident.

Thankfully, while these individuals were still in her home, she received a call from the Fairfax County Police Fraud Department. As soon as the scammers realized she was on the phone with law enforcement, they quickly packed up and left. According to the police, this group is known for similar scams and is currently under investigation.

Please keep the following in mind to protect yourself and your neighbors:

- **Never give money upfront** to any contractor or company without verifying their legitimacy.
- In Virginia, companies must have a permit to solicit door-to-door. Legitimate solicitors should carry a badge proving they're authorized to operate in the area.
- If someone comes to your door without a permit, contact Fairfax County Police right away.
- Always do your research before signing a contract. Look up company reviews, request references, and confirm their credentials.

Use trusted local sources: Many reliable contractors advertise in *The Rambler* and have already completed work in our neighborhood. Asking neighbors for referrals is another great way to find someone dependable.

Let's all stay vigilant and continue looking out for one another.

Zoning Updates: Telegraph Road, Highland Drive, Kingstowne

OR SALE

First, Fairfax County Department of Planning and Development staff has assigned the case involving 6801 Telegraph Road to its Tier II category for the coming year. However, the staff comment says nothing about the reuse of the office building as senior housing. Both the RHCA request and Franconia District Supervisor

Rodney Lusk's memo to staff specifically mention senior housing as the primary use for the existing building. RHCA wants to limit traffic emanating from the property and senior housing is the best choice. The plan also calls for up to 50 single-family units, a request supported by RHCA. Meetings involving citizens and the developers have already begun. A preliminary report will be available at the August 26 meeting.

Rather than deny a request for development of 30 homes on Highland Drive, the staff deferred the case to its Tier III category. That means the case can be rescheduled administratively WITHOUT a public hearing. Denying the case would have meant that a developer could NOT reapply for at least a year and a new case submission would trigger public hearings.

Highland Drive is now in the same category as the Rose Hill Plaza Shopping Center case. Either case

could resurface at any time. RHCA remains vigilant in its review of County actions.

Recently, a developer filed a zoning request for hundreds of new condos in Kingstowne. Development would take place atop the existing theaters and convert a nearby office

building to residential. RHCA is most concerned about increased traffic in the South Van Dorn, Franconia and Telegraph Road corridors. All three affect Rose Hill.

It should be noted that a high-rise residential building already has been approved for the vacant lot nearby. Originally zoned for office, the switch to residential would produce slightly less than the amount already approved. Increased traffic already has produced gridlock at peak hours on Van Dorn.

We have scheduled a presentation by the developer for 120 units of public housing on the current Franconia Government Center site for a meeting of the Rose Hill Civic Association on September 23. The yield would be 30 units per acre, approximately the same that is being sought for redevelopment of the Rose Hill Plaza shopping center, which also will include significantly less commercial space than what now occupies the site. — *Carl Sell*





Renovations at Franconia Rec Center Will Require Closures

If you are a regular visitor to the Franconia Rec Center, be prepared to change up your routine because work to install new heating, ventilation and air conditioning systems will necessitate temporary building closures and parking restrictions beginning Aug. 18.

The fitness center and racquetball courts will be closed from Aug. 18 to Sept. 16 with fitness equipment moving to the gymnasium along with the main entrance and check-in at the door located next to the parking lot closest to the gym.

Pool, family changing room and upper level rooms will be closed from Aug. 18 to Sept. 5.

Viriginia Hills Baptist Church Begins Construction With New Design

Construction has finally begun on a new Virginia Hills Baptist Church on Telegraph Road after months of work to redesign the project, which is now expected to be completed in late Spring or early Summer of 2026.

Paster Bart Purdy said the rapidly rising cost of labor and materials put the original design out of reach since money for the project came from proceeds from the sale of land by VHBC to Brightview Senior Living, which opened on the same site in July.



"We had to reduce the scope of our plan," Purdy said, "We eliminated the second floor, elevator, theatre seating, chapel, baptistery and multipurpose room," Paster Purdy said. "We went from eight classrooms to six, leveled out the sanctuary floor, went from theatre seating to stackable chairs and placed the stained glass (from the original church building) in the sanctuary (instead of a separate chapel)."

Purdy said the church will use a portable baptistery and the new building is designed so that a second floor and theatre could be added in the future.

The new church building will be shared with two other congregations — Kingstowne Communion United Methodist and La Hermosa Baptist — and the preschool, which currently operates out of Mount Vernon United Methodist Church, will return, but will be slightly smaller, Purdy noted.

"We look forward to interacting with the residents of Brightview, partnering with Rose Hill Elementary School to provide ESOL (English for Speakers of Other Languages) classes and being a resource for the community," said Purdy, who also wants to ask community residents two questions: What are the greatest needs of our community and what can our church do to meet those needs? 

Are Mosquitos Bugging You?

Frequent rains have made this a perfect year for mosquitos. Dealing with them is easy and inexpensive. The first thing to do is eliminate standing water on your property. Mosquitos can breed in the small amount of water contained in flowerpot saucers, toys, and even the rings of the black corrugated tubing commonly used for extending downspouts. Change bird bath water every 2 days and keep water in ponds moving with a fountain or a pump. To protect yourself from mosquito bites, wear long pants and sleeves or use repellents and use fans to blow away the mosquitos outside.



Water that cannot be immediately emptied should be treated by dropping in mosquito "dunks" or "bits." These products contain a natural bacterium called Bti that kills developing mosquito larvae before they can grow up and bite. Bti is harmless to anything that is not a mosquito larva. You can also fight mosquitos with a "mosquito bucket" that lures mosquitos to lay their eggs in Bti-treated water. These mosquito buckets are easy to make: put some leaves or grass clippings in a bucket, add water and ¼ small mosquito dunk. Also lean a stick against the side so frogs or birds have an escape route. You can get buckets for free from your grocery store bakery. Elephant mosquitos, which do not bite and eat other mosquito larvae, have bred in our bucket.

Do not spend a lot of money on commercial spraying. Spraying uses contact insecticides that will settle on the tops of foliage and kill any insect that encounters it. But mosquitos hide from the sun and predators <u>under</u> the leaves. So, spraying only kills the mosquitos that are flying when the spray occurs. Meanwhile the spray residue kills mosquito predators and pollinators. Worse still are bug zappers; they attract bugs with UV light, but mosquitos fly to heat and CO₂. It is mostly moths that get zapped.

Gardening in Rose Hill With Peggy Riccio, Virginia Horticulturist

As fall approaches, chrysanthemums step onto center stage. These popular blooming shrubs are available in gold, yellow, red and orange floral colors and symbolize the advent of autumn.

There are two types: florist and garden. Florist mums are about to bloom in containers at

local nurseries now. They are bred to bloom uniformly during the fall and temporarily add color to the landscape. These are not winter hardy. If you take them out of the container and plant them in the ground, they will not have enough time to establish roots. You can either treat them as disposable annuals or if you cannot handle throwing them out, you can try to overwinter them if you cut back the stems to about 4 inches after it blooms and cover the entire container and plant with mulch. Put it on its side in a sheltered location outside, like under a deck, and bury with mulch. It is okay if the foliage does not receive light if you remove the mulch in the spring.

Garden mums are winter hardy perennial shrubs that usually are purchased and planted in the beginning of the growing season. These are a better investment since they will come back year after year. These mums will need at least 6 hours of direct sun. Before you plant them, learn the mature size to determine the proper spacing, which will vary depending on



the type. After planting, mulch and water well and often until they are established. Fertilize with a balanced fertilizer (10-10-10) on a regular schedule until late August or early September.

If left to their own devices, mums will bloom in the summer. To have fall blooms, trim the branches back at the end of June, no later than

July. Any later and you will accidentally remove the buds. This also will increase branching which translates to more blooms.

In the fall, after they have bloomed, cut back the mums to about 4 inches and cover with mulch to prevent heaving. Or remove only the spent flowers, mulch, and then remove dead stems in the spring. Mums have shallow root systems so mulching before winter prevents them from being "heaved" out of the soil.

In the spring, remove mulch if it is covering the foliage, clean up any debris, and start fertilizing in the summer. Remember to put a reminder in your calendar to give it a trim in June. Then enjoy the colors in the fall!

Ask a Veterinarian By Casandra Fowler DVM

Q. What common household products are dangerous for pets?

We love our pets like family—and just like curious toddlers, they often explore the world with their mouths. But some everyday items we barely think twice about can pose serious dangers to cats and dogs.

Foods top the list of household hazards. Most people know chocolate is dangerous, but did you know baking chocolate and dark chocolate are far more toxic than milk chocolate? Other dangerous foods include grapes and raisins, which can cause kidney failure in dogs. Xylitol, a sweetener found in sugar-free gum, baked goods, and some peanut butters, can cause a sudden drop in blood sugar and liver failure—especially in dogs.

And onions, garlic, and chives, whether raw, cooked, or powdered, can damage red blood cells in both cats and dogs.

Medications are another common culprit. Over-the-counter pain relievers like

ibuprofen (Advil) and aspirin are toxic to pets, even in small doses. Acetaminophen (Tylenol) is especially dangerous to cats, who lack the enzymes to break it down—it can cause severe anemia and liver failure from even a small amount. Never give your pet human medication without veterinary guidance, and keep all prescriptions and supplements securely stored. Even medications and supplements marketed for pets—including those sold at pet stores or online—may not be safe for every animal. Some contain ingredients that interact with other medications or may be unsafe for pets with certain health

conditions. Always check with your veterinarian before giving your pet any new supplement or over-the-counter treatment.

Rodenticides (rat poison) are extremely dangerous for pets and one of the most common causes of pet poisoning. These baits are designed to be tasty and can cause internal bleeding, brain swelling, or kidney failure depending on the type used. Insecticides and yard treatments, even those labeled "natural," may also cause seizures, GI upset, or skin reactions—especially if pets walk through freshly treated areas and then groom themselves.

De-icing salts used on sidewalks and driveways in winter can irritate and burn paw pads and, if licked off, may cause vomiting or more serious health problems. Wipe your pet's paws after walks and consider pet-safe ice melt products around your home.

Plants bring beauty to our homes, but some are highly toxic to pets. Lilies, in particular, are extremely dangerous to cats—even licking a pollen-covered paw or chewing a single leaf can cause acute kidney failure. Other problematic plants include sago palms, tulips, oleander, and azaleas.

Cleaning products and automotive chemicals (like antifreeze) may smell interesting to pets and can be deadly. Even natural or "green" products may not be pet-safe. Check labels and consider switching to pet-safe alternatives, especially for surfaces your pets walk on or lick.

What should you do if your pet is exposed to something toxic? Call your veterinarian immediately—or contact the Pet Poison Helpline at 855-764-7661 or ASPCA Animal Poison Control at 888-426-4435. Time matters. When calling, be prepared to share the name of the product, how much your pet may have ingested, and when the exposure occurred. If possible, have the packaging on hand.

Take a walk through your home with your pet's perspective in mind. What can they reach? What could be chewed, spilled, or licked? A few simple changes can prevent a scary emergency—and keep your furry family members safe and healthy.
