Some letters are harder to write than others. It brings many mixed emotions as we live one day at a time.

The "Grace of God" never ceases to amaze us.

My right knee has hit the point of needing desperate attention. I'm now using a different Dr. With an MRI the bones show to be mismatched. At some time, the artificial knee has slid. With further investigation it does have infection inside the knee. We have cultured the fluids, and it was growing bacteria, but it also left a space that it might not be a correct reading; so I went in today and they cultured it again.

This brought up dental. So, knowing I needed one crown I went in only to find out I needed a molar tooth pulled, 2 root canals and 5 crowns to remove absolutely all the infection from inside.

This is where I need your prayers. My dental insurance is only a basic plan and will not cover most of this.

My health insurance SEEMS TO BE GOOD.

The surgeon says it will take more than one surgery. The first will be to clean and place a spacer in my knee to hold it together until we are sure all infection is gone. At this point I will be given large doses of antibiotics through IV's. We are looking at several months of treatment.

Please lift us up in prayer. After 38 years of service for the Lord, He has never left us stranded, nor failed to provide. Biggest prayer is to follow HIS lead. I have been told by many that this is totally going to be up to HIM for success.

Pray for Bro Joe he is actually my legs and his now.

As for Mya and her crew, they are making it well. They went back to the Tribal court for a check-in April 4th. The Judge was very disappointed with the lack of concern of the parents and their illegal activity. He informed Mya and Anjel go forward with the permanent guardianship papers. This is what they plan on doing.

The greatest of all is that the kids have stepped up to do the physical work in the church. Since they came forward and surrendered to serve our Lord they haven't missed a week. Adriel has taken over my classes of teaching, Cevin is reading scripture in front of the church for Pastor, Millie is bus captain and very faithful. , Anjel has taken over clean-up in the kitchen.

I have been teaching a lady's soul-winning classes for several months, Millie brought me a young man to share the gospel with one night after the bus route. He got gloriously saved and went home sharing with his family. Now, his Mom and younger brother are faithful to ride the bus. They know only a very little of the Bible. I sat and shared Jesus' hope with her last week. She knows this is what she needs but is still learning. Keep Nada in prayer. She has 4 children ages 10 to 17.

I was thrilled to lead Mya's 13-year-old to the Lord last week. We have been praying for her for quite a while. This made 4 of Mya's group who have received Christ since she took guardianship in August last year. These kids have been through a lot, what a joy to know their soul is taken care of.

With prayer, toil sacrifice, tears, pain and grief; who can put a price on a soul?

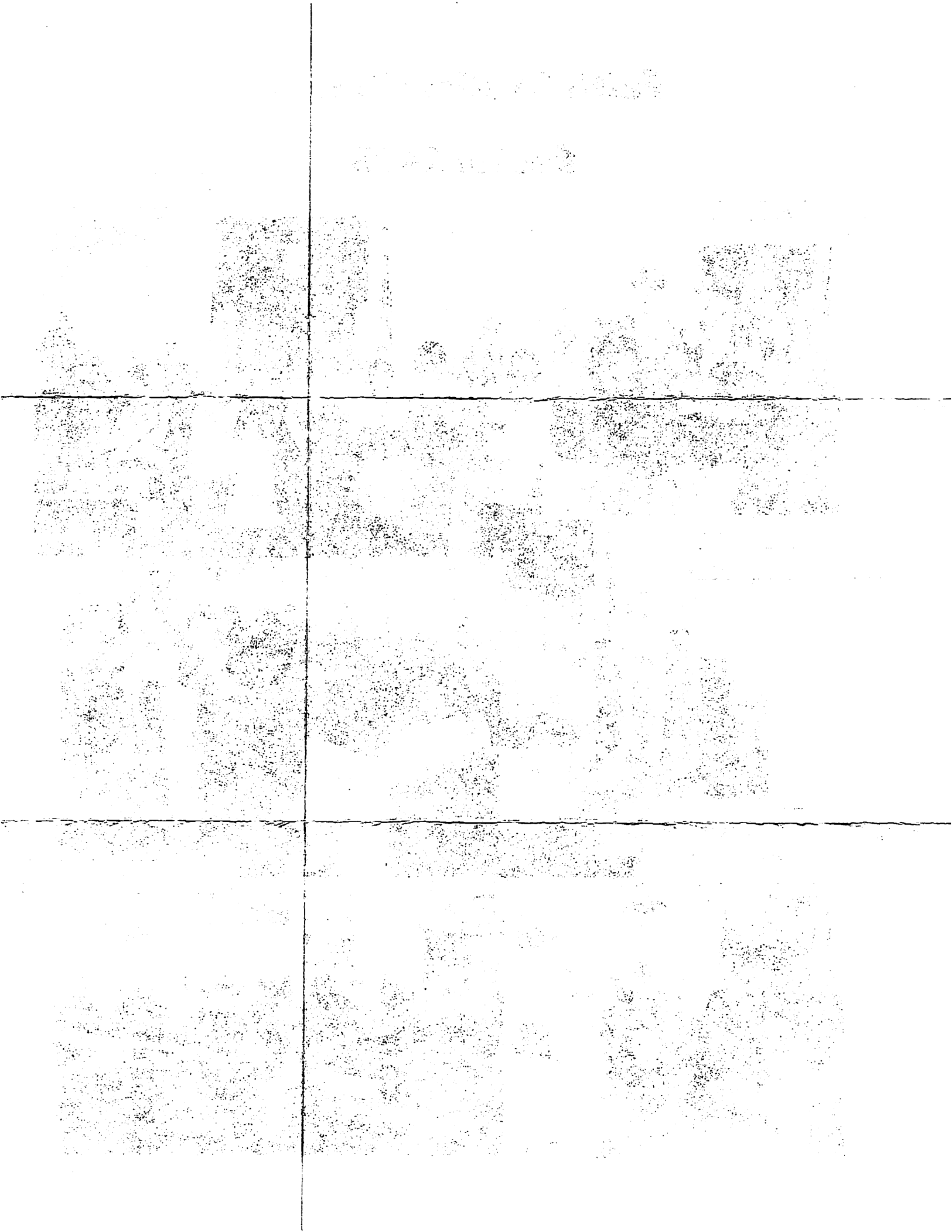
