Annual Ministry Report

CEF's ministry calendar runs from September 1st-August 31st, so that Good News Club ministries and all of summer ministries can be viewed on one report. It is always very exciting for us to finish up the report for the month of August so that we can see how the Lord has blessed the ministry the previous year. We thought we would take the time to share with you, our ministry partners, what God did in the ministry year of September 2024-August 2025 in the Greater Huntington Chapter.

There were:

- **93 total ministries conducted**
- **14,233 total children reached with the Gospel**
- **185 total 1st time salvation decisions made**
- **And 11 unchurched children were established in local Bible believing churches**

Praise the Lord for these types of results! Because you have invested your time,

prayers, and finances into this ministry, these Kingdom results could take place. Eternity has been impacted through you!

We cannot even begin to thank you enough. Words are not adequate enough, but that's all we have to give. You allow this ministry to move forward, and we are so grateful. Please continue to pray for us as we now move into the next ministry year. Our prayer is that we will see even greater results by this time next year!

Of course that's a famous quote from the Christmas Classic *It's a Wonderful Life*. Think of it with a different meaning for a moment. Every time we hear a bell ring, it reminds us of the great opportunity we have to reach the boys and girls for Christ in our public Schools.

For nearly the past 25 years CEF has been granted "equal access" to the public schools to conduct After School Good News Clubs. That's right ~25 years. June 11, 2001 was the day of that ground breaking United States Supreme Court ruling that gave us the same rights as any other extra curricular program.

Within that ~25 years, we have seen many boys and girls come to Christ. But, there are so many more out there who need the gospel. To put it into perspective, we are currently conducting 48 clubs but there are over 200 public schools in our Chapter.

There is, without a doubt, a public school within a few miles of your house or church that needs a sponsor for an After School Good News Club or a Junior Youth Challenge club. There are children in that school who desperately need Jesus.

Would you pray about getting involved in the Good News Club ministry? What if a

Principal said to you, "Would you tell the children in my school about Jesus?" What would your response be? Well, guess what? In many circumstances, that's what's happening. But we need volunteers to adopt the schools. Is God calling you and your church to adopt your local school? For the answer look up Mark 16:15.
