# TUITION POLICIES & FINANCIAL AGREEMENT

1. **Annual Commitment:** Tuition is an annual financial commitment. By enrolling, families agree to the full year's financial obligation, regardless of the payment plan selected.
2. **Payment Schedule:**
  - Billing: Monthly payments are billed on the 1st of the month.
  - Due Date: Payments are due by the 15th of the month.
  - Online Fees: Families paying via the online portal are responsible for covering the processing fees.
3. **Late & Delinquency Policy:** Accounts not paid by the 15th are considered delinquent.
  - 30 Days Delinquent: The student may not attend class until the account is brought current.
  - 60 Days Delinquent: The student is considered withdrawn from the Academy.
4. **Withdrawal & Refund Policy:** While the Financial Agreement is an annual commitment, the School Board will work with families in good standing who must withdraw due to unforeseen circumstances.
  - Fees: All Application, Re-Enrollment, and Curriculum fees are non-refundable.
  - Tuition (Monthly Plan): Families are responsible for the tuition payment for the full month in which the student withdraws. No further tuition payments will be billed.
  - Tuition (Paid in Full): Families who paid the year in full will be refunded for all full, unused tuition months remaining in the school year (August-May) following the withdrawal.

## FINANCIAL AID

**The Lisa Samples Scholarship Fund:** Families experiencing significant financial hardship may request a scholarship application from the Church Finance Office. These funds are limited, based on need, and awarded at the discretion of the Academy Administration.

**Ministry Discount:** A discount is available for families where at least one parent works in vocational Christian ministry (full-time or part-time).

**Application:** Families must apply for these discounts annually.

**Eligibility:** The final determination of eligibility and the specific discount amount is at the sole discretion of the Academy Administration based on the ministry's annual budget.
