evidence of the Genesis Flood is of great significance to our generation. We must make these discoveries known. To move forward on that mission, IBA has commissioned a professional film production team to develop a 30-40 minute documentary and trailer of our discoveries. 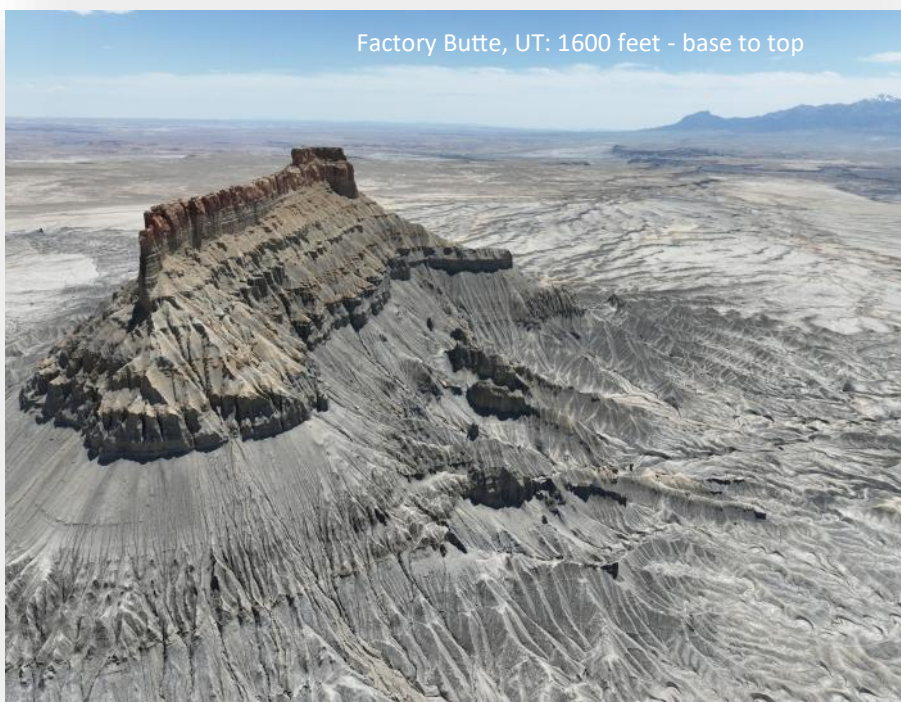
### How can you follow this project?

How did this monster of a butte end up left behind in the middle of the Utah desert? It rises 1600' above the desert floor with water erosion all around it. # ***The Greatest Legal Battlefield in American History :***

## ***March 1925: The 100th Anniversary of the Scopes Monkey Trial— Dayton, TN***

*Clarence Darrow: “Do you think the earth was made in six days?”*

*William Jennings Bryan: “Not in six days of twenty-four hours.”*

*Darrow: “Doesn’t it say so?”*

*Bryan: “No sir.”*

*Darrow: “Does the statement, ‘The morning and evening were the first day,’ and ‘The morning and evening were the second day,’ mean anything to you?”*

*Bryan: “I do not see there is any necessity for constructing the words, ‘the evening and the morning,’ as meaning necessarily a twenty-four hour day...”*

*going on for a very long time?”*

*Bryan: “It might have been continued for millions of years.”* 1 Trial Transcript: pp 302,303

Those answers given by William Jennings Bryan, Defender of the Christian Faith and Bible, to Clarence Darrow on Day 8 of the trial shook the courtroom and the world. Today I wonder why Bryan, three-time presidential candidate, great American orator, leader of the anti-evolution campaign, Bible expert and Christian fundamentalist that helped introduce legislation in fifteen states to ban teaching of evolution, could not defend the creation week being six literal twenty four hour days. If he understood the Hebrew word for day used in scripture was “yom”, that each day was numbered, and defined by morning and night, and Exodus 20:11 and 31:17 written by the finger of God himself declares “For in six days the Lord made the heaven and the earth...”, Bryan should have had a solid foundation to declare the truth of the creation week as it is described in the Bible. But he caved under pressure, and in so doing, undercut the reliability of God’s Word, and thus was a factor that led millions of people over the past 100 years to abandon belief in God.

Why was the *Scopes Monkey Trial*, American history’s “greatest legal battlefield”? Because the event that’s often called the trial of the century was truly a battle—not physical like the American Revolution but spiritual. Its outcome cast doubt on the authority of God’s Word, implying that either Scripture is true or science is. This legal battle has impacted views on faith and science for the past century.

Why does this matter? It is by God’s Word, Genesis to Revelation, that we can know God’s plan for our salvation. If any part isn’t completely true, why would we trust the rest of it? Let’s take a look at the 1925 trial to see what it actually proved.

### **The Trial**

In March 1925 the Tennessee state legislature passed the anti-evolution law HB 185, called the Butler Act after legislator John Washington Butler. He’d heard about a young woman who came home from college

believing the evolutionary theory and had therefore rejected her religious heritage. Butler introduced the bill in hopes of limiting the dangerous teaching of evolution.<sup>1</sup> With this bill's passage, a legal challenge was just waiting to occur; and occur it did. John T. Scopes, a substitute teacher and coach in Dayton, agreed to be charged with illegally teaching evolution. Two national icons faced off in the subsequent trial—**William Jennings Bryan for the prosecution** and **Clarence Darrow for the defense**. They and their teams went at it for eight days in the Dayton courthouse.

The trial reached a tipping point when **Darrow** called **Bryan** to the stand. He poked holes in Bryan's arguments by exposing his lack of scientific knowledge and inconsistencies in his position. Scopes was ultimately found guilty and fined, but that courtroom exchange presented the Christian creation position as unscientific and the Bible as nonfactual.

Eventually the Butler Act was overturned. Today's public schools generally provide only one-sided evolutionary teaching. Just as Christians feared in 1925, the idea that science has disproven the Bible has prompted many young people to question or leave their faith.

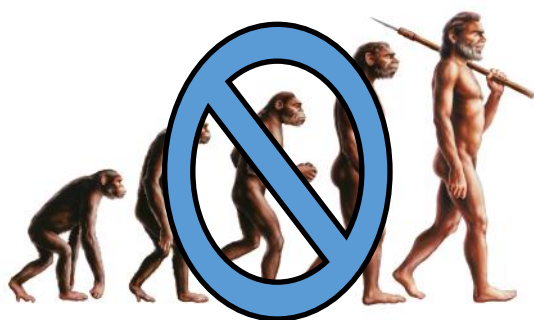
### **The Scientific Case for...Evolution or Scripture?**

In the 1925 trial, Clarence Darrow and his team of attorneys used testimonies from so-called experts to demonstrate that evolution was true science. The supposed experts presented some of the following topics as proof. Many are still used, but the scientific evidence actually supports creation, not evolution. Consider the claims and our brief responses.

**Claim:** Animal/plant evolution from simple cells to complex life, bacteria to man, is a fact.

**Response:** The trial experts admitted they didn't know where the first cell came from and weren't clear on the process or method evolution uses.

Biological science has advanced considerably since then, and it overwhelmingly disproves evolutionary ideas about how life operates. In fact, ICR President Dr. Randy Guliuzza recently introduced a new theory proposing that God equipped each life form with the ability to adapt to environment changes using its own innate systems.<sup>2</sup> Modern science supports the Bible like never before.



**Claim:** Ape-to-human evolution is demonstrated by fossils.

**Response:** The so-called missing links between ape and man are still missing. No discoveries show that humans descended from primates, and the fossil specimens presented in the trial and since have turned out to be fully man, fully ape, or fraudulent.<sup>3</sup>

**Claim:** The geological record proves evolution because simple life forms are buried in the deepest geological layers.

**Response:** The fossil record documents the ecological zones that were progressively flooded and buried in the global Flood of Genesis. This interpretation is supported by ICR geologist Dr. Tim Clarey's research using oil well drilling samples from all over the world.<sup>4</sup>

The Flood also explains the Cambrian Explosion, the fossil creatures whose living counterparts show no sign of evolution, and the original tissue found in fossils that suggests recent burial.<sup>5</sup> The Bible best explains the geological observations.

**Claim:** The earth is millions of years old, allowing for evolution to have occurred.

**Response:** Many dating methods used to assign millions-of-years ages to rock specimens are based on unprovable assumptions and/or produce inconsistent results.<sup>6</sup> Much evidence clearly supports a young earth and coincides with the biblical timeframe of around 6,000 years.



**Claim:** The tailbone, appendix, wisdom teeth, and other organs are vestigial features.

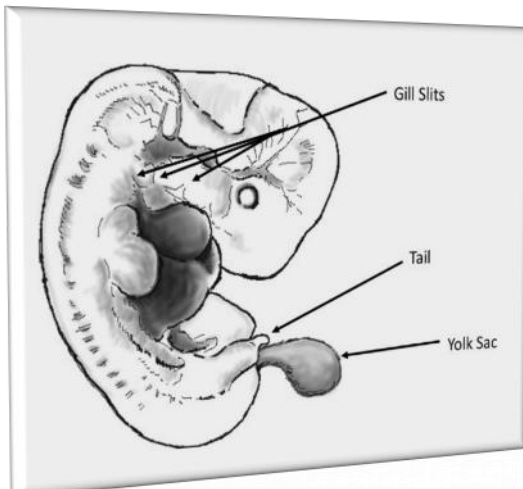
**Response:** Parts of organisms once thought to be useless evolutionary leftovers are today known to have important functions.<sup>7</sup> They were designed according to God's plan.



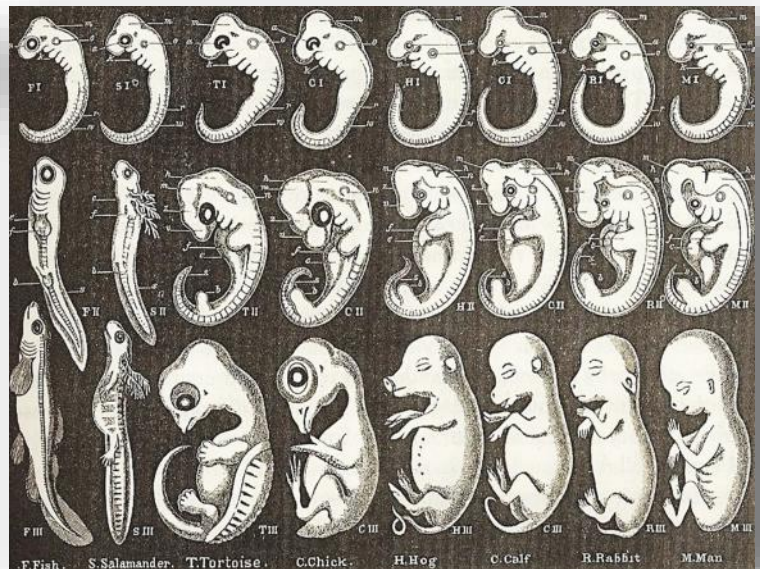
**Claim:** Genetic similarity and breeding results support evolution.

**Response:** Human and ape DNA is now known to be 84% similar, not 98% as initially claimed.<sup>8</sup> And variation between plant and animal species can be managed by controlled genetic breeding. This is not evidence of gradual change driven by random mutations and chance over millions of years.

**Claim:** Embryonic development and comparative embryology between animals prove that living organisms came from a common ancestor because their developing embryos echo evolutionary stages.



**Response:** This idea was popularized in 1866 by Ernst Haeckel. He was later reprimanded for using fraudulent drawings. Unfortunately, students are still told that developing babies go through evolutionary history with gill slits, a tail, and yolk sacs, even though this is false.<sup>9</sup>

## Conclusion

Sadly, Williams Jennings Bryan died just five days after the trial's conclusion. But his last speech, published after his death, demonstrates the convictions he communicated at the trial remained strong. "Christians know that the fear of the Lord is the beginning of wisdom now, just as it has been in the past, and they therefore oppose the teaching of guesses that encourage godlessness among the students....Evolution is not truth, it is merely an hypothesis--it is millions of guesses strung together. It had not been proved in the days of Darwin...It had not been proved in the days of Huxley, and it has not been proved up to today."<sup>10</sup>

Indeed, it still has not been proven. If Bryan had had modern scientific evidence and knowledge to take on Darrow's questioning, the Scopes trial outcome might have been very different. However, the great battlefield's results continue to spread misinformation, imaginary histories, and ungrounded speculations as evidence of evolution, even though biological science points to phenomenal complexity and design by the all-wise, all-powerful Creator, Jesus Christ. Christians have science on their side affirming the truth of God's Word. The evidence shows us we can be confident that the Word of God is completely true and lasting, and we can believe its message of life and hope through Jesus our Redeemer. # Gravity in Creation

**When Did God Create Gravity and what impact did it have on the first three days of Creation?**

Have you ever seen one of these fun science lab toys called a radiometer? It looks like an upright light bulb and inside it has 4 fins on a spindle. Notice that each one of those four fins has a black side and a white side. When you hold it up to a light source, the fins will spin around. The reason for this is because the white side of the fins reflect light and the black side of the fins absorb the light, **creating a heat exchange**. The stronger the light source, the faster it spins. It doesn't work without a light source.



Let's look at the text of creation, Genesis 1:2 says, "The earth was **unformed** and void, darkness was on the face of the deep<sup>1</sup>, and the Spirit of God hovered over the surface of the water." [CJB]. Most of us



automatically assume that the Spirit of God is somehow moving over the surface of the earth's ocean. We have the idea that the ocean already exists in Genesis 1:2 and the land hasn't been formed yet. Let me share with you my insights from the Hebrew text...

This water that the Spirit of God hovered over was what He made the entire universe out of, and at that point in time the Earth had a future location in the center of that mass of water **but the earth was unformed, including its own ocean!** That's hard to wrap our minds around. There was a construction site somewhere in the middle of the deep sphere of water; the only 'building material' at the construction site was water. The dirt and rock that land is made out of didn't exist yet. The earth didn't have its own outline and shape.

If I were to ask you, "What did God make first?" your answer is probably going to be "Light", but what did He make before He made light? Water! **Why would He make water first? Here's a possibility:** Water, 'H<sub>2</sub>O' is at the lower end of the periodic table. In the process of creating light, was He also creating all the other elements that He was going to use for His creation?

My hypothesis is: at the beginning of the first 24-hour day, gravity did not exist! What exactly is gravity? The Oxford Dictionary (2009) defines it as 'the force that attracts a body to the center of the earth or other celestial body. The degree of this is measured by acceleration.' Liquid water in micro gravity is sphere shaped, [On the International Space Station they have a lot of fun with it!]

**And just exactly how big was this ball (sphere) of water? How much volume did it have to begin with?** Its name is 'Těh-hōme'<sup>1</sup> and it means '*deep liquid water in continuous movement*'. That's the Hebrew way of saying that **it was a massive, vast amount of liquid water!!** I'm convinced that it was much larger than the circumference of the earth.

Why does it say that the Spirit of God was **hovering** over the surface of the waters? (The Israelites understood 'hovering' to be like that of the Middle Eastern hummingbird in hovering flight. They also have insects like bees that hover. **How fast was He hovering?** Was it faster than the speed of light?

Because of it being sphere shaped, the Spirit of God would have been completely encasing the whole surface of the sphere of water while He was hovering over it. What effect would that have on the surface of the water? What was the temperature of the water when He began hovering over it and what temperature was it when God said, "Is Light"? Was the temperature cooler in the center than at the surface? The 'homeschool-mom-science-teacher-mind' in me wants to know!

The next thing we read in scripture in the English versions, "Then God said, "Let there be light"; and there was light." (verse 3). In Hebrew it says, 'And He says Elohim, "Is light" and is light.' [He created it!] Then He inspects it with His own eyes (an anthropomorphism of observation by God) and declares it to be good. Verse 4 reads, 'God saw that the light was good'

**AND NOW He is about to set in motion the laws of gravity...not only for the earth, but also for the whole universe.**

Then we read, 'and God divided the light from the darkness. God called the light 'Day' (in Hebrew '**to be hot**'), and the darkness he called 'Night' (in Hebrew '**to fold back or twist**'<sup>2</sup>) and there was evening, and there was morning, Day # One (Yom Echad<sup>3</sup>). How did He do that? My guess is that it involved some kind of heat exchange. Because of the Hebrew translation of the word **day meaning 'to be hot'** and the Hebrew



translation of **night meaning 'to twist'**, I am thinking God put this principle into place when He separated the light from the darkness on Day One. Apparently, the whole sphere of water, however big it was, spun in a complete circle in 24 hours, which was the beginning of time. The process of spinning also began the laws of gravity.

Let me add my further insights to this discussion: God divides the water into two separate bodies and puts outer space in-between. **Consider this:** If you take a massive sphere of water and spin it, the centrifugal force is going to cause the outer perimeters to go flying outwards, and if there is no gravity to put boundaries around it, it will continue to travel outwards. It's only boundary is the very process of spinning. It's my understanding that at the end of the first night and day 24-hour cycle, the massive, deep body of water spinning in a complete circle caused the surface area to go flying outwards and form the vacuum of space in the process. The earth was the residue water left in the middle by the end of Day Two. So, by the end of the second 24-hour night and day cycle, gravity is fully operational.

**What is the mechanism that keeps outer space stretched out?** The two waters above outer space. They might work like the opposing currents in moving water in a river or ocean that create whirlpools. [And a side note to this: In Isaiah 34:4 & Revelation 6:14 the sky is going to roll up as a scroll. All God has to do is tweak those opposing current and the whole universe could roll up!]

On the Third Day (a 24-hour night and day cycle) He lays the foundations of the earth. [Keep in mind that at that point in time there was no sun or moon, or other planets, or even a solar system to exert gravitational pull on the earth.] The Hebrew says that He made two bodies of water to stand erect, one body standing on top of the other<sup>5</sup>. There were two residual bodies of water left at the center of the spin of Day # Two. The inner body of water was bigger than the outer body of water and had enough gravity to pull the smaller outer body of water towards it. **Gravity would cause the solids to move to the bottom of each body of water.** The bottom layer would be the center of the earth, then there would be a massive body of water called the Great Deep. Then that would be covered by the lesser body of water with the solids forming the dry land, and the liquid above it forming shallow lakes, oceans, rivers, and atmosphere. 2 Peter 3:5 & 6 sums this up by saying, "it was by God's Word that long ago there were heavens, and there was land which arose out of water and existed between the waters , and that by means of these things the world of that time was flooded with water and destroyed." [CJB].

Ps 136:6 also describes the original land as having a vast amount of water underneath, saying "To Him who **spread out** the earth above the waters" [ESV].

On the third day the LORD also created and filled the dry land and sea floors with seed bearing plants. None of these plants floated away into space because the earth now had its own gravitational force as it spun around during the third 24-hour day / night cycle.



To sum it up: Gravity did not exist until God separated the light from the darkness, which caused the sphere to spin around. With the rotation of the earth we now have a method of measuring time... One evening and one morning graphically depicting a 24-hour period... one day.

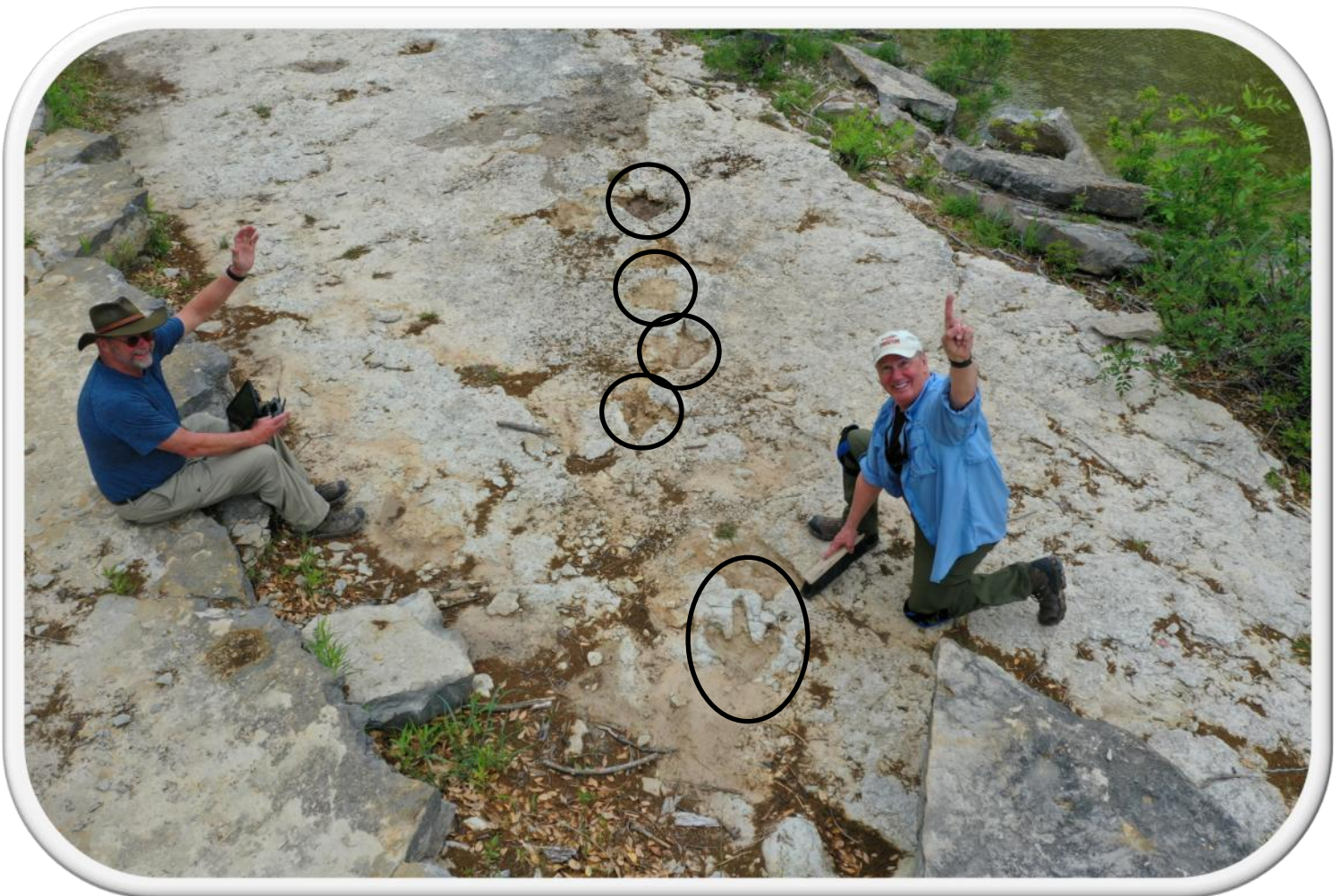
