Minutes of the Grace Lutheran Council Meeting on Thursday February 8th, 2024

The Grace Lutheran Church Council meeting was held on Thursday February 8th, 2024, at 6pm with Mark Briley presiding. Also present: Adam Wientjes, Rhonda Lorenz, Dylan Jordan, Lindsey Moeller, Travis Schulz, and Terra Koistinen, LeRoy Bullis, Steve Schlenner, Denise Biller, Claudia Frentz, Paul Henrichs, and Wyatt Sprouse. Also present: Kat Anderson. Absent: Kelly Evjen. Opening by Kat Anderson and roll call by Dylan Jordan. A motion to approve the agenda was made by Adam Wientjes and seconded by Rhonda Lorenz. Motion carried. Adam Wientjes motioned to approve the minutes from January, and Travis Schulz seconded. Motion carried.

Items:

Financial Report – The total monthly contributions to the general fund was \$15,699 the weekly giving average was \$3,925. The average weekly worship attendance for Sunday was 75, and Wednesday was 26. A motion to replace ChurchArt-Online with Canva Pro by Travis Schultz was seconded by Denise Biller. A motion to accept the financial report and pay the bills was made by Dylan Jordan and seconded by Adam Wientjes. Motion carried.

Current Plans and Updates – Members of the congregation are assisting in leading worship on February 11th with Jo Vitek giving the message. Jack Holmquest is going to do the Ash Wednesday service at 6:30. A meal will be in the fellowship hall before the service. We are in communication with the bishop about an interim pastor. Nancy McClanahan will be doing service on February 18th. The council is looking into a way to honor Pastor Cheryl's service to the church and will present a card shower to her.

Old Business:

- **1. Open Council Seats**-Two members of the congregation expressed interest to fill the open council seat. The council decided not to take a vote tonight but to table it until next meeting so that they have time to verify the interest.
- **2. Choir Room** LeRoy provided updates on the choir room. The lighting is being worked on to retrofit to the existing fixture locations. Carpet has been ordered and can be installed after the lighting is complete. **New Business:**

1.Staff Support -

a.Administrative Assistant – Kat is in the process of interviewing. A new job description was developed. Denise Biller motioned to approve the description. Steve Schlenner seconded the motion. Motion carried.

b.After asking Kat Anderson to leave the room, Staff Support had a discussion. Travis Schultz on behalf of Staff Support motioned to provide back pay (September through December) of \$3,000 and an additional \$300 per pay period (February through May) going forward to Kat Anderson for taking on the additional duties of the Youth Director until one is hired. Denise Biller seconded the motion. Motion carried.

c.Lindsey Moeller motioned that the church financial audits be carried out by a 3rd party, starting with 2023. Denise Biller seconded the motion. Motion carried.

d.Adam Wientjes motioned to move staff reviews to the Executive Committee and Staff Support Committee instead of doing peer/coworker reviews. Dylan Jordan second the motion. Motion carried.

e.Pastor Cheryl had sent a letter from her leasing company to request that the church pay for the \$950 early termination fee at the apartment she was renting in Watertown. Travis Schulz motioned to deny the request citing the agreement when she gave notice of her retirement. Terra Koistinen seconded the motion. Motion carried.

- **2.BeFrienders & Visitations** after discussion, it was decided that at the moment, we would not consolidate the BeFriender's program with Lutheran Church of Our Redeemer. It was also decided that nursing home weekday services would cease until an interim pastor was chosen.
- **3.Grant Requests** Kat Anderson listed the grants that she was going to request on behalf of the church for capital improvement and education.
- **4.Call Committee** Lindsey and Denise stepped up as members of council to be on the call committee. Paul Henrichs reported that his daughter, Brooke, also wanted to be on the call committee. The members of the council are going to start conversations with members to join the call committee which can have up to 10 members per the GLC Constitution.

5. Ukraine Fund -

Continued...

a. Pastor Cheryl submitted a letter to council requesting that the Refugee Fund be transferred to Lutheran Church of Our Redeemer along with the remaining gift cards and have LCOOR be the stewards/managers of the account. Travis Schulz motioned to deny the request to transfer because of the 3rd party audit that is planned. Steve Schlenner seconded the motion. Motion carried.

b. Dylan Jordan motioned to create a process for funds to be accessible to the current refugees that came in under Pastor Cheryl. Paul Henrichs seconded the motion. Motion carried. Kat Anderson will create a funding request form in the meantime so that there is still opportunity to serve the refugees as the church intended.

Committee Reports:

Education, Youth, & Family – There will be no changes to Wednesday school with the exception of Ash Wednesday. The NOLA trip is cancelled after conversations with parents. They instead are looking into a youth retreat or camp closer to home. Lock in on February 23rd. Kids sing Palm Sunday.

Foundation- Grant requests are due February 15th. They meet March 4th to award the grants. Wyatt Sprouse volunteered to take the open council seat on the Foundation Board. Thank you to Gena Urevig for being a council representative on the Foundation Board for your terms!

Fellowship & Outreach – Chili cook-off January 20th went well. Celebration of Love coming up February 10th. The Easter Egg hunt is in the beginning planning stages. 1st Responders' Meal is on May 17th. If any members can help, contact Denise, Darcy, Terra, or Kat.

Finance & Stewardship – Car Show planning in the works and details are coming together. The Jamboree has been cancelled. SCRIP sales are going good. It would be nice to have more people sign up on the RaiseRight App.

Mission – Mission of the Month is Hope in God/Divine Providence.

Memorial - Denise will be council representative on Memorial Committee.

Preschool – New laptop was purchased to replace the current one as it started to malfunction. Registration for Fall will open soon, and graduation planning is underway.

Property – Working on lighting in multi-purpose room. There's a section in the Narthex by the brown doors that has failing mortar & cement. LeRoy has been getting on the roof to seal it with caulk but there needs to be a more permanent solution to prevent leaks.

Safety – Would like to add more cameras so that all entrances are covered.

Worship & Music- Kids sing on Palm Sunday.

LeRoy Bullis motioned to adjourn the meeting; Paul Henrichs seconded the motion.

The meeting was adjourned with the Lord's Prayer.
