





WHAT IS THE ANNUAL CATHOLIC APPEAL?





St. Thomas Aquinas School enters its 25th year with thanksgiving towards those who have sacrificed for over a quarter of a century to make Catholic Education possible in the City of Rio Rancho. We are grateful to our benefactors, parents, volunteers, faculty, and staff for all of your sacrifices and great generosity. Your time, talent, and financial resources are helping our school build a lasting legacy. We are pleased to announce that St. Thomas Aguinas School has received full accreditation through the Western Catholic Educational Association (WCEA) at the highest level of recognition for a full six year term. WCEA is a third party of experts and educational leaders who review every aspect of our school. Their evaluation has found that our school fully meets all criteria in every category of accreditation. We happily share with you that they stated, "STAS clearly embraces their mission statement, modeling the faith in every aspect of school life and teaching students to live out these values". We are grateful to our school's WCEA Leadership Team. We are thankful for our students and families who support our school's mission.

Latest Updates:

- We now have fiber optic internet connections throughout the entire facility. This will better support our current technology needs, and also set us up for the future.
- We have continued HVAC repairs and maintenance on the units.
 The HVAC air filters will be replaced every six months for every unit, and units will be repaired as needed.

- Our Outdoor Art Room is completed. Through the support of a grant from the Catholic Foundation, we were able to revamp the Rosary Garden and create a beautiful outdoor art classroom. Painting among the roses and learning outside will be so much fun!
- Outdoor musical instruments have been installed in the school's garden area This musical metamorphosis set is complete with instruments in the shape of a caterpillar and butterfly. This is also thanks to a grant through the Catholic Foundation.
- We have purchased The Hallow App for the entire school community. All of our faculty, staff, and students will now have a Hallow account to access lessons, meditations, and prayers. Each student will be able to share this account with their parents/guardians.
- We have upgraded our reading program in Kindergarten this school year to the Superkids curriculum for Catholic schools. This program will help teach phonics, writing, and reading skills with a focus on the joy of learning and building a solid foundation. We will be expanding this program to our first and second grade annually until we completely upgrade our curriculum at the primary level.
- We continue our focus on traditional learning and classical skills in reading. We have purchased brand new class sets of novels for third to 8th grade. We can't wait to enjoy these novels in our literature lessons.
- In addition to all of these improvements, our facility team completed the regular summer overhaul to the facility with new paint, carpet cleaning, stripping and waxing of floors, moving of furniture, and repairs.

We send our sincere thanks to our parish community for your wonderful support of our school over the last 25 years. The sacrifices and gifts you have made toward Catholic education have taken root and impacted the lives of well over a thousand STAS graduates. May God bless you!
