IF YOU ARE ATTENDING A DISCIPLESHIP GROUP AT THE SOUTHWEST BIBLE CHURCH ("SWBC") BUILDING LOCATED AT 4625 W. WILLIAM CANNON DR., AUSTIN, TX 78749 ("DISCIPLESHIP CENTER"), AND YOUR CHILDREN WILL BE AT THE DISCIPLESHIP CENTER DURING THAT TIME, PLEASE CAREFULLY READ THE FOLLOWING POLICIES AND TERMS OF USE, WHICH INCLUDE A WAIVER OF CERTAIN LEGAL RIGHTS:

Discipleship Center Usage Policy:

For the health, safety, welfare, use, and enjoyment of all who may use the Discipleship Center, all use of the Discipleship Center by children is subject to the Discipleship Center Usage Policy. In addition, the following policies and rules apply:

- No staff or representative of SWBC will be monitoring my children or otherwise responsible for my children while at the Discipleship Center.
- No person, adult or child, should enter the Discipleship Center who is feeling or showing any of the following new or worsening signs or symptoms of possible COVID-19 as described by the U.S. Center for Disease Control, including:
 - Cough
 - Shortness of breath or difficulty breathing
 - Chills
 - Repeated shaking with chills
 - Muscle pain
 - Headache
 - Sore throat
 - Loss of taste or smell
 - Diarrhea
 - Feeling feverish or a measured temperature greater than or equal to 100.0 degrees Fahrenheit
 - Known close contact with a person who is confirmed or suspected to have COVID-19
- Any sickness, accident, or injury occurring during your use of the Discipleship Center, or any sickness arising within 72 hours after using the Discipleship Center should immediately be reported to the SWBC staff.
- Although we are taking measures to maintain a safe and sanitary environment, there are still risks of being exposed to and potentially getting sick with COVID-19 or other illnesses.

Assumption of Risk, Waiver, and Release:

I understand that while at the Discipleship Center during the time of the Discipleship Group, my child may engage in activities that could lead to accidents or other events in which my child may be injured or become sick, whether due to items or other persons (including other children) at the Discipleship Center and that there will not be a certified caregiver supervising such activities.

I acknowledge that I have read, understand, and voluntarily, knowingly, and by my signature below expressly accept and agree to use the Discipleship Center in accordance with and subject to the policies set forth above and I fully assume all risks associated with use of the Discipleship Center by my child(ren) and me; and

I further waive all claims I have or may have in the future against SWBC, its directors, officers, employees, agents, and representatives related to my use of the Discipleship Center related to my Discipleship Group, and I release them from any liability related thereto.
