Further, the Participant (and Participant's parents or guardians if participant is a minor) releases or promises to indemnify, defend, and hold harmless the Activity Sponsor for any injury arising directly or indirectly out of the described Activity, whether such injury arises out of the negligence of the Activity Sponsor, the Participant, or otherwise.

If a dispute over this agreement or any claim for damages arises, the Participant (and Participant's parents or guardians if participant is a minor) agrees to resolve the matter through a mutually acceptable alternative dispute resolution process. If the Participant and the Activity Sponsor cannot agree upon such a process, the dispute will be submitted to a three member arbitration panel for resolution pursuant to the rules of the American Arbitration Association.
