



**VENTURE CHURCH/JOURNEY STUDENT MINISTRY  
2025 STUDENT CAMP MINOR-PARTICIPANT AGREEMENT**

**ASSUMPTION OF RISK, WAIVER AND RELEASE OF LIABILITY, and INDEMNIFICATION**

In consideration for the right for my minor-participant to participate in the 2025 Student Camp scheduled for 07/07/25 – 07/11/25, hereinafter referred to as the “**Event**”, sponsored by Venture Church/Journey Student Ministry, which includes the use by my minor-participant of Venture Church Keller premises and/or Generate Camp by YM360 premises located at East Texas Baptist University in Marshall, TX and/or transport to/from Generate Camp by YM360, I hereby agree to all of the terms and conditions in this agreement, including specifically the **ASSUMPTION OF RISK, WAIVER AND RELEASE OF LIABILITY, and INDEMNIFICATION** provisions.

**ASSUMPTION OF RISK.** I understand that there are **inherent risks** of injury in the use of Venture Church Keller and/or Generate Camp by YM360 premises and/or transport to/from Generate Camp by YM360 while participating in the Event. I also understand that there are **risks of injury in participation in the Event** that take place outside of Venture Church Keller premises, including but not limited to Generate Camp by YM360 and transport to/from Generate Camp by YM360. (**collectively, “Risks.”**)

I understand that such **Risks** include but are not limited to slip and falls, trips, collisions, overexertion, loss or theft of property, equipment failure or malfunction, drowning or other accidents or incidents that may result in harm, loss, disability, death or other injury or damage to minor-participant. I understand that such injuries may include, but are not limited to, minor or major personal, physical, bodily, emotional, mental, economic, property or other types of injuries or damages.

I understand that such injuries may be caused, in whole or in part, by the negligence of Venture Church/Journey Student Ministry and/or Generate Camp by YM360, its directors, employees or agents, me, my minor-participant, other participants in the Event, and/or members or other guests.

**I fully understand and appreciate, knowingly and voluntarily accept, specifically same responsibility for, and freely choose to allow my minor-participant to participate in the Event which includes the use of Venture Church Keller premises and/or Generate Camp by YM360 premises and/or transport to/from Generate Camp by YM360 in spite of the Risks of injury set forth above.**

**WAIVER AND RELEASE OF LIABILITY.** On behalf of myself and my spouse/partner, minor participant, parents, guardians, heirs, next of kin, personal representatives, assigns and estate, I hereby voluntarily and forever release and discharge Venture Church/ Journey Student Ministry from covenant and **agree not to sue** Venture Church/Journey Student Ministry or its directors, employees or agents for, and waive any and all present and future claims, demands, actions, causes of action, damages, losses or any other alleged liabilities or obligations, whether known or unknown, for any injuries (which includes personal injuries and property damages) to me or my minor-participant sustained in the use of Venture Church Keller premises and/or Generate Camp by YM360 and/or transport to/from Generate Camp by YM360, which arise out of, result from or are caused by, the negligence of Venture Church/Journey Student Ministry. (**“Waived Claims”**)

**INDEMNIFICATION AND LEGAL DEFENSE.** I agree to **defend, indemnify, protect and hold and save harmless Venture Church/Journey Student Ministry or its directors, employees or agents** against any and all **Waived Claims**, including but not limited to those arising out of, resulting from or caused even in part by Venture Church/Journey Student Ministry’s negligence or its directors’, employees’ or agents’ negligence, as well as any other claims arising out of, resulting from, or caused by the use of Venture Church Keller premises



and/or Generate Camp by YM360 premises and/or transport to/from Generate Camp by YM360, which arise out of,

result from or are caused by, the negligence of Venture Church/ Journey Student Ministry or its directors, employees or agents. (**"Waived Claims"**)

Further, authorization and permission is hereby given to Venture Church/Journey Student Ministry to furnish transportation to and from the Event for my minor-participant utilizing charter bus services and/or personal vehicles belonging to church representatives as needed.

**The minor-participant herein described has permission to engage in all prescribed activities for the Event, except as noted by me.** I am entrusting the care of this minor participant to the directors, employees or agents responsible for the Event. I hereby give permission to the physician selected by same to order x-rays, routine tests, and treatments for the health of my minor-participant, and in the event I cannot be reached in an emergency, I hereby give permission to the physician selected by the directors, employees or agents for the Event, to hospitalize, secure proper treatment for, and to order injection and/or anesthesia and/or surgery for my minor-participant as named below. I also authorize said physician or any physician or hospital who has previously treated my child, to disclose any information thus acquired, if requested, to the Venture Church/Journey Student Ministry insurance carrier.

Should it become necessary to send my minor-participant home for disciplinary reasons, I assume the responsibility of transporting my minor-participant home. I also consent to the minor-participant's belongings being searched at any time while participating in an activity during the Event and the confiscation of any unauthorized items by Venture Church/ Journey Student Ministry, its directors, employees and agents.

**Pictures of the Event will be taken and used for publications including social media.** You must give written notice to Venture Church/ Journey Student Ministry if you do not want your minor-participant's picture included.
