A TIME FOR...GIVING GIFTS...

Year-end giving is always important to the overall financial health of our church. The following are a variety of ways you can give to our church in 2025 that will make a difference for years to come.

Gifts of cash or check...

are the simplest and most popular means to donate. Gifts given in the offering, delivered to the church or school office, or mailed and postmarked by December 31 qualify for a tax deduction in 2025, even if a check does not clear your account until after the first of the year.

Online Giving...

is available. Our church uses Pushpay to give online. Scan the QR code to the left and follow the prompts to give your donation by credit card or bank account. Alternatively, you can text "vvfirst" to 77977. The same rules apply to credit card contributions as to cash or checks: they must be received by December 31.

Appreciated Securities and Property Assets...

that have grown in value over the years, such as stocks, bonds, mutual funds, and real estate can bring you greater tax savings than gifts of cash. If you have owned such assets for a year or longer, you may deduct the fair market value on the date of transfer, even if they were purchased at a lower price. By donating appreciated assets, you will avoid paying capital gains tax on the increased value of the asset, which can provide the donor with additional savings.
