Privacy Policy

Purpose:

This Privacy Policy pertains to the website www.greatdividecalvary.org, which is owned by Wordpress and managed by Subsplash. This page aims to inform you about how we gather and process information, including your personal data that you share with us when visiting our website. Our aim is to provide clarity and transparency about how we handle your data on our website, ensuring that you always have control over your personal information.

What is personal data?

Personal Data includes any information that can be (reasonably) used to identify a person. This includes not only the obvious data like name or date of birth, but also other information, such as location data, IP addresses, and online identifiers. We take your privacy and personal data protection seriously, and we only collect, process, and store your personal data in compliance with the applicable data protection laws.

Types of Data collected:

- Information you provide directly to us, for example by filling out forms on our website. This data, depending on the purpose of the form, could include your name and email address.
- Data automatically collected through Google Analytics
- Visitor IP address and browser user agent string

Purpose of Data collection:

- Legal compliance
- Event organization
- Feedback and communication
- Making bookings for group events
- Analytics and user insights

Lawful Basis for Data collection:

By legally processing your data, we rely on the lawful basis of the Colorado Privacy Act (CPA: https://coag.gov/app/uploads/2022/01/SB-21-190-CPA_Final.pdf). The CPA is relevant for the collection and processing of data provided by residents of Colorado. Residents from other states are protected by the lawful basis of their home state.

According to the CPA, the following duties apply to the collection of your data (C.R.S. § 6-1-1308):

1. Duty of Transparency (provision of an accessible, clear and meaningful privacy notice)
2. Duty of Purpose Specification (clear expression as to why data is collected)
3. Duty of Data Minimization (collection only of data that is adequate, relevant, and reasonably necessary)
4. Duty to avoid Secondary Use (only using data for its stated purpose)
5. Duty of Care (using reasonable security measures)
6. Duty to avoid unlawful Discrimination (ensuring processing does not violate state- or federal anti-discrimination laws)
7. Duty regarding Sensitive Data (not processing sensitive data without user consent)

Data processing:

Storage: We utilize secure servers and data storage systems to safeguard your personal information. We implement reasonable security measures to protect your data from unauthorized access, disclosure, alteration, or destruction. While we take reasonable steps to protect your data, we cannot guarantee absolute security. Please be aware that the transmission of data over the internet carries inherent risks, and you assume these risks when providing your information.

Sharing: We may share your data with third parties such as Zelle, or our current online giving solution. If you share your data for the purpose of group bookings, such as our bi-annual trip to Cerritos, we may share your data with transportation and accommodation providers. These third parties are contractually obligated to protect your data and use it only for the purposes for which we share it. We may also disclose your information when required by law, in response to legal requests, or to protect our rights, privacy, safety, or property. Furthermore, visitor comments may be checked through an automated spam detection service.

Protection: We use SSL certificates to protect all transmission of data on our website. We provide 128-bit encryption on most pages on our website to ensure that communications are secure. We are committed to protecting your data and complying with applicable data protection laws. If you have any concerns or requests regarding the use of your personal information, please contact us using the information provided in the "Contact Us" section of this website. You have the right to access, correct, or delete your personal information. If you wish to exercise these rights, please contact us.

Retention: We will keep your information, including personal data, for as long as we need it to offer you services, follow the law, and solve any problems with others. All the personal data we keep will follow the rules in this Privacy Statement. If you want to know how long we will keep a specific type of personal data about you, just get in touch with us using the contact info below. If you leave a comment, the comment and its metadata are retained indefinitely. This is so we can recognize and approve any follow-up comments automatically instead of holding them in a moderation queue.

Consumer Rights:

Users of our website are protected according to the following "Personal Data Rights", specified in § 6-1-1306 of the CPA.

1. Right to Opt Out (consumers are able to opt out of the processing of their personal data)
2. Right of Access (consumers are entitled to gain clarity on whether controller is processing personal data and to access it)
3. Right to Correction (ability to correct inaccurate personal data)
4. Right to Deletion (consumers can request personal data to be deleted)
5. Right to Data Portability (controllers must be able to provide personal data in a usable electronic format)

Depending on your place of residence, your consumer rights may differ and are applicable.

Your rights to personal information are not absolute. Depending upon the applicable law, access may be denied: (a) when denial of access is required or authorized by law; (b) when granting access would have a negative impact on another's privacy; (c) to protect our rights and properties; (d) where the request is frivolous or vexatious, or for other reasons.
