### **Approval of Vestry Minutes**

Don moved to approve August 2025 Vestry Minutes; Dee seconded. Motion passed.

#### **Old Business**

A) Motion was passed in August to change the number of candidates for future vestry elections. Discussion resumed at this vestry meeting, exploring options.

Susan moved to approve a change to 4 candidate slate for the 3-year terms, beginning in 2026. The motion was seconded. Motion passed unanimously by members present.

B) Discussion followed about Galilee and the Montessori School. Susan moved to close the school effective 2025-2026 school year. Dee seconded the motion. A majority of vestry voted to close school, with Fr. Buchanan abstaining, and Bud voting nay.

### **Rector's Report**

A) Vestry Election and Candidates

Tonight we need to complete the discussion and vote around the vestry election slate. I want to be clear about the process I've suggested, and make sure that each of you understand that the congregation still has input on the front and back end of this process--as well as the nominating committee in the central part of the process.

Step 1: We solicit the congregation for nominations.

Step 2: Nominations are vetted by Rector and Parish Administrator

Step 3: Vetted names are forwarded to the nominating committee, who has received guidance about hoped-for vestry composition.

For example: we currently have 9 people on vestry from the 9:15 service--given that the 9:15 represents just over half our Sunday attendance--we should aim for 6 to 7 people from that service.

Additionally: We presently have an even divide between female and male.

Step 4: Nominating committee prays and discerns and presents a slate of 4 for the annual meeting.

Step 5: At the annual meeting, a vote is taken about whether or not to accept the slate: Yea or Nay.

This approach is used by many large and successful parishes--it is not unusual or strange.

# B) August/September

I'm grateful to our staff and parishioners who have all helped to get us off the starting block this fall. We've had a solid start to the fall programs, with the Women's Bible Study beginning this week, very strong attendance at youth groups, and a wealth of toddlers and babies. "In it Together" has begun thanks largely to Marshall and Callie Everettt-and the 20-30 age small group is meeting monthly at the Buchanan home. This past Sunday we ran out of parking at 9:10am. Special thanks to Bryant McGann who has overseen the golf cart ministry and now a parking team.
