Also, you must enroll in Moms Together and attend regularly to qualify for these options. If you are absent from a Moms Together meeting, but your child is in attendance, you will be charged a \$50 childcare fee per child.</p>

1. ENROLLMENT REQUEST FORMS

BRIDGEPOINT MEMBERS:

MONDAY, DECEMBER 1ST AT 12 PM

BridgePoint members will receive a link to the members enrollment form via email. Members may request enrollment for their children or grandchildren. Members will also receive a 15% discount on all tuition and enrollment fees. The initial tuition payment will be due on Monday, January 12.

CURRENT BELA FAMILIES:

MONDAY, JANUARY 12TH AT 12 PM

A link to the form will be sent via email and brightwheel to current families when enrollment begins. Children will be placed in classes based on the order in which the online enrollment form is received electronically. We do our best to ensure current families receive placements for all their children. The initial tuition payment will be due on Monday, January 26.

2. PAY YOUR TUITION

The registration fee and last month's tuition must be paid **by the due date** indicated on your brightwheel invoice to finalize your child's enrollment. If payment is not received by the due date, your child's spot in the program may be forfeited. The registration fee is **nonrefundable**. To withdraw from the program, please notify the assistant director, Suzy Foley, in writing by emailing sfoley@bridgepointbible.org. The last month's tuition is refundable only if withdrawal from the program is sent in writing by **June 30, 2026**.

3. BRIGHTWHEEL REGISTRATION FORM

You will receive an invitation to complete the online brightwheel registration form. The online form must be completed **by January 31, 2026** for all those registering in December and January or **by February 28, 2026** for those registering in February. If your registration form is not received by the deadline, your child's spot in the program may be forfeited. Refunds will not be given if your spot is forfeited due to an incomplete registration form.

4. HEALTH FORMS

A current Health Statement form (indicating your child had a medical exam on or after September 1, 2025) and a current copy of child's immunizations must be on file **before your child may start school**. Throughout the school year, you will be asked to submit new health forms when the form we have on file indicates it has been more than 12 months since your child's latest medical exam.
