Intentional Conversations about Loving Our Neighbors Resolution #4

Whereas The Northwest Synod of Wisconsin(NWSWI) of the ELCA, walking in the way of Jesus, takes seriously the greatest biblical commandment to "Love God and to love our neighbors as ourselves." (Matthew 22:39)

Whereas Martin Luther reminds us that responding to God's grace by loving our neighbor also means caring for the physical and social needs of our neighbor (The Forgotten Luther II pp.89, 93)¹ and

Whereas our baptismal promises call us "to care for others and the world that God has made and work for justice and peace" (ELW p. 228) and

Whereas we often have sinned and fall far short of loving our neighbors as ourselves, especially our neighbors who are Black, Indigenous or Persons of Color (BIPOC)

Whereas intentionally and unintentionally we have contributed to a way of life that has harmed our BIPOC neighbors and

Whereas racism and racial disparities permeate the state of WI, especially in the health of babies, children and adults, in incarceration rates, and in education and

Whereas at the April 2021 synod assembly and at the September 2021 the synod council approved the *Synod Racial Justice and Equity Statement* written by members of the synod youth board and the synod justice team; and be it

Resolved, that the 197 congregations of the NWSWI be encouraged to engage in ongoing intentional conversation about race and love of BIPOC neighbors using the synod's Racial Justice and Equity Statement and accompanying Glossary of Terms in that discussion and publicly take action in their communities consistent with that conversation; and be it further

Resolved, that in addition to promoting the relationship building resources of Neighbor to Neighbor, other resources be provided for adult and cross generational conversations about race and love of neighbors by the Synod Justice Team and Synod ministers; therefore be it further

Resolved, that rostered leaders and SAMs note in their annual report to the Bishop the length and type of intentional conversation and any action(s) taken promoting racial justice and equity and loving our neighbors.
