

Weekly Discipleship Plan (Week of October 19th)

Shorter Catechism Question:

Q. 26. How is Christ a King?

A. 26. As a king, Christ brings us under his power, rules and defends us, and restrains and conquers all his and all our enemies.

Scripture Memory: Exodus 20:1-10 And God spoke all these words, saying, "I am the LORD your God, who brought you out of the land of Egypt, out of the house of slavery. "You shall have no other gods before me. "You shall not make for yourself a carved image, or any likeness of anything that is in heaven above, or that is in the earth beneath, or that is in the water under the earth. You shall not bow down to them or serve them, for I the LORD your God am a jealous God, visiting the iniquity of the fathers on the children to the third and the fourth generation of those who hate me, but showing steadfast love to thousands of those who love me and keep my commandments. "You shall not take the name of the LORD your God in vain, for the LORD will not hold him guiltless who takes his name in vain. Remember the Sabbath day, to keep it holy. Six days you shall labor, and do all your work, but the seventh day is a Sabbath to the Lord your God. On it you shall not do any work, you, or your son, or your daughter, your male servant, or your female servant, or your livestock, or the sojourner who is within your gates.

DAILY DEVOTIONS

Reading: Leviticus 20

Questions: How does God's condemnation of child sacrifice reflect His love and care for children?

Why do you think God puts so much emphasis on sexual relations and morality?

Discuss how understanding these laws can impact our view of sin and God's righteousness.

<u>End with prayer</u>: pray for the spiritual revival of the community and nation.

Day 2

Reading: Leviticus 21-22

Questions: How do these verses challenge our views on physical and moral integrity?

What does this passage teach about the consequences of violating God's laws?

How can we ensure that our actions do not lead others to profane what God has set apart?

End with prayer: pray for the effectiveness of Bethel's ministries.

Day 3

Reading: Leviticus 23

Questions: How does the Feast of Tabernacles serve as a reminder of the Exodus journey?

How can we apply the principle of humbling ourselves before God in our daily lives?

How can modern society practice the act of leaving the edges of their 'fields' for the less fortunate?

<u>End with prayer</u>: pray for opportunities to share the gospel with family and friends.

Day 4

Reading: Leviticus 24

Questions: How does the story of the blasphemer challenge us to think about our words and actions?

What role does repentance play in crimes against God or other people, according to the Bible?

How can we demonstrate respect for life and property in today's society?

<u>End with prayer</u>: pray for the church-planting movement in Mexico.

Day 5

Reading: Leviticus 25

Questions: How does the Jubilee year challenge our contemporary economic systems?

How do the instructions regarding the treatment of servants reflect on issues of labor rights today?

In what ways does the chapter challenge you to reconsider your understanding of wealth, ownership,

and prosperity?

<u>End with prayer</u>: pray for growth in spiritual maturity and personal discipline.

Day 6

Reading: Leviticus 26

<u>Questions</u>: How does God's promise of blessing for obedience encourage you in your spiritual journey? In what ways does this passage illustrate the importance of confession and humility before God?

How can you apply the teachings of this passage in your personal prayer life?

End with prayer: pray to gain a deeper understanding of what it means to be "in Christ."

Day 7

Reading: Leviticus 27

Questions: What is the significance of an item or person being "most holy to the LORD"?

In today's society, what does it look like to give the best of what we have to God?

How can we use this passage to understand better the holiness and seriousness of our commitments to God?

<u>End with prayer</u>: pray for a greater understanding of God's character and ability.
