HOW TO COMPLETE AND PROCESS THE SECURITIES DONATION FORM:

1. Get a copy of this form from the Celebration website, Church App, or church office.
2. Complete the middle section of the form - listing your Name, Address, Email, and Phone Number.
3. Complete the name of your Dealer/Brokerage, your Account Number, and the FAX Number of the relinquishing institution.
4. The **FAX number of the relinquishing institution is a required field** – this must be included on the form.
5. To ensure a timelier transfer of your securities, we encourage you to include the Dealer #, DTC Number, and CUID of the relinquishing institution. You may need the assistance of your advisor/broker to complete these account details.
6. List the Name, Number of Shares/Units, Symbol/CUSIP, and Approximate Value of the investment you wish to donate. You may need the assistance of your advisor/broker to complete these investment details.
7. Read, sign, and date the section at the bottom of the form.
8. The completed form should be emailed to service@credential.com for processing. Please also CC Shane Krupa, Thrive Wealth Advisor in your email – shane.krupa@thrivewealth.ca . This can be sent by you or your advisor/broker. Always send the form to Credential – not your institution.
9. To allow Celebration to be aware of your donation, please provide a copy of the completed form to the Celebration Office Manager – ideally by way of an email copy to info@redroof.tv for tracking purposes.
10. Credential's back office will contact the relinquishing institution (Nominee or Fund Company) by way of fax to the FAX number on the form – requesting the transfer of your investments.
11. Credential and your institution “talk” and move the funds “in kind” to Credential.
12. Start to finish, this process could take a number of weeks. This is important to remember for year end donations in December, or near your corporate year end.
