II. Course Description

An overview of the historic doctrinal formulary of the Church of England and its importance to the greater Anglican tradition, with primary emphasis on the interpretation of the Thirty-Nine Articles. Also, compares and contrasts the Articles with other Reformation confessions.

III. Course Objectives

- A. To place The 39 Articles in their historical and theological context.
- B. To introduce a proper hermeneutical paradigm for the interpreting The Articles.
- C. To provide a sense of how The Articles are understood and used in the Reformed Episcopal Church and the Anglican Church in North America.
- **D.** To give an overview and exposition of the Articles, taking into consideration contemporary issues.

IV. Course Requirements

- A. <u>Writing Assignments</u> (45% each): Follow the CTH Style Sheet for Papers (see the CTH Writing Lab here: https://sites.google.com/view/cth-writing-lab/home)
 - a. Write a 10-page paper showing how the teaching of Article XXVII (Of Baptism) is expressed in the Baptismal Office of The Book of Common Prayer. Try to show connections in wording as well as allusions to Biblical texts.
 - b. Write a 10-page paper showing how the teaching of Article XXVIII (Of the Lord's Supper) is expressed in the Eucharistic Office of The Book

of Common Prayer. Try to show connections in wording as well as allusions to Biblical texts.

- B. Reading (10%): Each student taking the course for credit is to read all of the required resources and give an honor statement at the end of class giving an account of the percentage of each text that is read. The required reading encompasses:
 - a. Read all of E. H. Browne's Commentary EXCEPT his commentary on Article III (it is a bit confusing!). Instead, read Gibson's commentary on Article III (pp. 159-180) which may be found here: https://prydain.files.wordpress.com/2010/07/ the thirty nine articles of the church gibson.pdf
