

Diversity and Marriage Statement

CCCA's Philosophy of Education

CCCA's philosophy of education is based upon a Biblical worldview that has been developed out of a literal interpretation of the Bible, as presented in the New King James Version. It is impossible to disconnect our learning and development from the power and purposes of our Creator God. At the very core of CCCA's worldview and philosophy of education is God's Word. It is the foundation of CCCA's philosophical framework. From the origin of man to ethics and morality, we believe all logic and reasoning is based upon the tenets of Scripture. It is upon this premise that Calvary Chapel Harrisburg – West Shore built and developed Calvary Chapel Christian Academy. The governing bodies of both the school and the church are in full agreement with CCCA's philosophy of education.

CCCA's philosophy of education is based upon our Biblical worldview and not upon the philosophy of man. All truth is God's truth. God's Word is truth according to the Scripture (John 17:17, NKJV) and according to the conviction of the Holy Spirit. As such, CCCA's philosophy of education is defined by our master teacher Himself, Jesus Christ. Teaching should be personal and individual. All methods, instructional practices, activities and assessments will be geared toward allowing the learner to better understand the knowledge of God and be better prepared to serve the Lord through successfully navigating and interacting with the world around them. We are set apart for God by understanding His truth; God must be at the core of all the principles, facts and truths we teach.

CCCA develops the curriculum and programs of the school based upon a Biblical worldview. A Biblical worldview is an assurance that the knowledge gained will be based upon God's truth and not just the correlations made by respected men and women of science, history, mathematics and language. While these respected individuals have made vast contributions to our understanding of the world around us, our understanding is not complete until we filter it through God's Word. Our knowledge of God and His Word should cause us to fear no vain philosophy or body of knowledge. We have real truth in our hearts and in Scripture, and with such knowledge and truth we should be able to disprove the fake and vain philosophies of the world. The better we know the creation, the better we know the Creator. With a strong Biblical worldview, the disciplines of math, science, history and language are but a mere platform for believers to express the goodness of God, the truth of His Word and to praise Him for His many blessings.  - 6. Applicants provide past evidence of emotional stability and a satisfactory record of behavior and attendance.

ADMISSION PROCEDURE

- 1. Submit completed application to church office.
- 2. Church will pass on application to administration when Application Checklist Requirements have been met.
- 3. Based on CCCA's Criteria for Student Admission, the administration reviews the application to establish compatibility.
- 4. Interview with an administrator is scheduled.
- 5. Interview process includes:
 - a. Declaration of salvation and testimony of child and/or parent(s).
 - b. Church affiliation
 - c. Academic review
 - d. Academic testing (when applicable)
 - e. Disciplinary review
 - f. Get acquainted
- 6. After the interview process, the administration team prayerfully confirms that the family and student have met the criteria required for acceptance.

IMMUNIZATION REQUIREMENTS

Pennsylvania Department of Health School Immunization regulations require that: <u>All pupils must be immunized</u> <u>or exempted before admission to any school in Pennsylvania</u>. Immunization data must be received for all students, including all Pre-Kindergarten programs.

Children may be **registered** without proof of immunizations prior to the start of school. However, in order to **attend** school, written proof of a minimum of at least one dose of each required vaccine is required. This is called a **provisional** admission. When a student is admitted **provisionally**, a plan for completing the immunizations must be submitted by the parent(s). Provisional records will be reviewed every 60 days. If the plan is not followed, or the provisional period expires before immunizations have been completed, the student may be excluded from school until evidence of immunization or exemption is submitted. <u>All immunization must be completed within 5</u> days after the first day the child attended school.

There are two categories of **EXEMPTION** from the immunization requirements:

- Religious exemption Students need not be immunized if the parent or guardian objects, in writing, to the immunization on religious grounds or a strong moral or ethical conviction.
- Medical exemption Students need not be immunized if a physician or his/her designee states, in writing, that the immunization may be detrimental to the health of the child. This may be either a temporary or permanent status. When the physician determines that the immunization is no longer detrimental to the health of the child, the exemption ceases to be valid and the child must be immunized.

Parents of all exempt students should be aware that if the Pennsylvania Department of Health declares an epidemic of a disease for which immunization is an admission requirement, students who are exempted will not be permitted to attend school for the duration of the epidemic.

2025-2026 TUITION SCHEDULE

Kindergarten - 12th Grade Tuition:

\$250 Enrollment fee per child (Due May 8th with Application Submission) This fee is non-refundable and will be used to process your children's renewal application or new application.

Per Child \$6,500.00 per year (\$650.00 per month for 10-month installment plan, August thru May)

FOURTH CHILD DISCOUNT:

The "Fourth Child Discount" allows the fourth child in a family to attend CCCA tuition FREE (\$250 Enrollment fee still required).

Before and After School Programs:

Before School Program (7:00am - 7:30am (per child/per day) \$7.00

After School Program (3:30pm - 5:00pm (per child/per day) \$12.00

Unlimited Monthly Before/After Care (per child/per month) \$235.00

PAYMENT OPTIONS:

- One Payment: 100% tuition is due before Thursday <u>August 1st</u> (5% discount).
- 2. 10 monthly payments are due for August through May between the 1st and 10th of the month.

ELECTRONIC PAYMENT by credit or debit card.

1. There is a 2% fee on all credit and debit card transactions and/or through on line payments

MID-YEAR ENTRY:

When a student enters the school during the year, tuition will be charged for each month the student is registered (regardless of the number of days in attendance the first month) on the basis of $1/10^{\text{th}}$ of the annual tuition. The first payment will also include \$250 Enrollment fee.

MISCELLANEOUS:

- No re-registration will be accepted if there is a balance due on an account.
- Enrollment fee is not refundable.
- Re-registration or application fees are not refundable.
- If your child is withdrawn during the course of the school year, you will be charged for the total days that your child was enrolled.
- Your child can be dismissed from CCCA for late/unpaid tuition or fees.
