What You Need to Know About the Copyright Law

When can I photocopy?

This question is asked every day by pastors and church musicians nationwide. Church professionals and volunteers desire to respect the rights of copyright owners, but are sometimes confused by copyright law. It is always best to contact the publisher or copyright holder for permission to reprint, project, record, or make copies of any copyrighted material. The following situations are based on the copyright law of 1976, and list what you can do without having to secure prior permission.

1. Reproducible pages.

The original purchaser of an edition may copy specific parts only marked 'reproducible.' This may include reproducible congregational pages for selected responses or hymn stanzas, or perhaps instrumental scores that are specifically marked 'reproducible.' Only editions marked 'reproducible' may be copied by the original purchaser for use in their particular setting.

2. Licensed hymnody and worship songs.

Hymns and songs may be copied that are covered by a license purchased by your congregation, such as CCLI, OneLicense.net, LicenSing, and other independent licensing agreements secured from other publishing entities.

3. Public domain works.

The following are expressly prohibited:

- 1. Copying to avoid purchase.
- 2. Copying music for any kind of performance.
- 3. Copying the text of an anthem for congregational bulletins without permission or copyright notice.
- 4. Copying without including copyright notice.
- 5. Copying to create anthologies or compilations.
- 6. Reproducing material designed to be consumable, such as published inserts.

Copyright ultimately means that no one but the copyright owner has the right to copy without permission.






