### **MINUTES**

**Call to Order** – PeADD Board Chair, Ms. Crissy Carter, called the meeting to order at 12:03 pm with a quorum present. The meeting was conducted in-person at Pennyrile Area Development District and virtually via Zoom.

Pledge of Allegiance & Invocation - Mr. Scott Marshall led the pledge and Judge Mack McGehee led the invocation.

Approval of Minutes - The August 14, 2023, Board of Directors Meeting Minutes were presented for review and approval.

**MOTION** – Judge Perry Newcom made a motion to approve the minutes as presented. Mayor Bill Hesser seconded the motion. With no questions or comments on the floor, the motion carried.

**Financial Report** – Mayor Kevin Cotton presented the Monthly Financial Report as of August 31, 2023, for review and approval. He stated that 16.67% of the budget should be expended and it is currently at 10.17% expended. Mayor Cotton mentioned that the Staff Travel line item is 16.33% due to the many conferences held within the last month. Overall though, the budget was below projections at this time.

**MOTION** – Judge Kota Young made a motion to approve the Monthly Financial Report as presented. Mr. Scott Marshall seconded the motion. With no questions or comments on the floor, the motion carried.

**Federal & State Reports** – Legislative updates were provided by Ms. Morgan Alvey, Field Rep. for U.S. Senator Mitch McConnell's office, Mr. Alex Caudill and Ms. Martha Jane King Field Reps. for Department for Local Government.

#### Staff Reports -

1. Community & Economic Development – Ms. Amy Frogue, Director, Community & Economic Development (CED), discussed the Energy Resilience Survey, located in the board packet, and how the data received from it will enhance the region's resilience against disasters and long-term power outages. They survey will be released, Friday, September 15th and will conclude at the end of November. The PeADD GIS department is tracking responses to chart critical facilities mentioned in the survey. Ultimately, Ms. Frogue noted, the survey will help to identify generators needed and will assist in securing state and federal funding when it comes available.

Next Ms. Frogue mentioned the House Bill 9 initiative discussed in the PeADD Press Newsletter, stating that the application has been released as of the end of August. She detailed that this is state funding to provide match dollars for federal funding opportunities for projects that are in energy priority communities, which includes all of the Pennyrile with the exception of Christian and Trigg Counties. DLG has established the program and the GRANT program and will review those applications based on designated criteria.

Ms. Frogue pointed out that 10 projects were submitted for Inter-Governmental Review last month. She asked that anyone with comments about those projects to submit those quickly so they can be submitted for the review process. Lastly, she reminded the board of the Regional Transportation Committee Meeting taking place the following day at 10am in the large board room at the PeADD office. She stated that boost points will be assigned to transportation projects seeking funding, therefore attendance is important to place those points on projects that are important to the region.

2. Area Agency on Aging & Independent Living – Ms. Jill Collins, Director, Area Agency on Aging & Independent Living (AAAIL), began by stating that September is a busy month for the Aging department with many events taking place. She stated that September 25-27, the Pennyrile Senior Games will take place in Hopkinsville and is geared



towards all individuals 50 years of age and older. The goal behind the Senior Games is to promote an active lifestyles and healthy aging. The next event she highlighted was the Walk to End Alzheimer's event on Saturday, September 23<sup>rd</sup>. It is in partnership with the Alzheimer's Association and PeADD staff have a team that has raised funds through activities in the office and will be onsite to participate. She stated that the funds raised for the event go to research for Alzheimers and other related dementia. The National Family Caregiver Support Group Program is to provide peer support, supportive services and support groups and is facilitated through the PeADD office.

Ms. Collins mentioned that last month she had discussed the Kentucky Caregiver Support Program beginning this month stating that the program has had an overwhelming response and is providing support to grandparents raising grandchildren in their home. She introduced Ms. Christi Combs, who was recently hired to coordinate the program.

Ms. Collins highlighted four seniors that will be recognized on September 22<sup>nd</sup> at the University of Louisville for receiving the Gold Standard Award due to leading engaged and flourishing lives and inspiring those around them with a zest for life. Individuals receiving the award must be 85 or older. Those being recognized are Mr. Frank McReynolds, Ms. Barbara Jordan, Mr. Jack Webber, and Ms. Janette Sharp, all of Todd County.

Lastly, Ms. Collins mentioned that September is National Senior Center Month. She stated that there are nine senior centers located in each county of the Pennyrile region and all are considered multi-functional centers offering many services at each one including a hot meal along with physical and social activities. However, the most important asset to senior centers is the socialization they provide for the seniors that visit. She invited everyone to visit the senior center in their county to see first-hand the comradery and services that takes place.

3. West Kentucky Workforce Board – Mr. Tom Sholar, Business Liaison, West Kentucky Workforce Board, spoke on the many activities taking place in the region. He discussed the collaborations with the SWK EDC in assisting with new businesses locating in the area. He also mentioned that anyone who has job openings should contact the business liaisons to get those jobs posted for the public to see. Mr. Sholar went on to discuss the various job fairs taking place soon including the monthly job fairs at the Hopkinsville Career Center beginning on September 9 and the yearly Job Expo in Madisonville on October 24. He briefly mentioned several successful expungement events that took place in Muhlenberg County, Hopkins County and Christian County. He stated that these events are great opportunities for companies to hire individuals with misdemeanors and lower-level felonies to get them back into the workforce. Mr. Sholar discusses the Talen Pipeline Management for Healthcare which is being spearheaded by the Kentucky Chamber of Commerce with the local Hopkinsville-Christian County Chamber participating in it. He explained what it is and the benefits of it. Lastly, he congratulated Ms. Amanda Davenport who had recently been elected the KAED Chair-Elect and mentioned the meeting recently held in Madisonville which sparked great discussion among the attendees.

Mr. Derek Poor, WKWB Veterans Transition Liaison, informed the board of activities taking place with transitioning military and some new efforts he is leading to get them more interested in the manufacturing opportunities available in western Kentucky. He also mentioned the Fort Campbell Jumbo Job Fair taking place October 17 and 18.

#### **New Business**


- 1. **Monthly Code of Ethics Report** Ms. Crissy Carter, stated that there had been no Code of Ethics issues or violations reported this month.

Other Business - There was no other business.





### **ASSISTANCE FOR SENIORS WITH MEDICARE**

If you're low-income and paying \$164.90 per month for your Medicare Part B premium, there's a program that can help. The Medicare Savings Program (MSP) may pay for some or all of your Part B premium, as well as deductibles, coinsurance, and copayments. To qualify, your income must be under \$1,660/ month if you're single or \$2,239/month if you're married, and your assets must be under \$9,090/individual or \$13,630/couple.

### **HONORING OUR VETERANS**



West Kentucky Workforce **Board Veterans Transition** Liaison Derek Poor works at Fort Campbell several days each week serving transitioning military and their

spouses. Mr. Poor works with business and industry to assist them in hiring former military who have great skills and work ethic.

On October 31, a Manufacturing Seminar was held where transitioning service members met with manufacturing representatives including Ascend Elements, Toyota Boshoku and White Drive Products.



Mr. Poor also participates in weekly job fairs at Fort Campbell as well as the 2-day Jumbo Job Fair which was held on October 17-18. On average over 350 transition out of the military each month. Mr. Poor assists those individuals in finding employment with hopes of them staying in the local area.

### **OCTOBER JOB FAIRS**

October has been a busy month for Job Fairs across West Kentucky. Along with the weekly job fairs at the Paducah and Hopkinsville Career Centers, West Kentucky Workforce staff participated in the annual Job Expo in Madisonville on October 24, the Muhlenberg County and Crittenden County Job Fairs on October 25.







Over 170 jobseekers attended the Job Expo. There were 38 employers on site and 8 agencies represented.



### **YOUTH SUCESSES**

Haley Worley visited Youth Workforce Connections (YWC) program at Hopkinsville Community College determined to make positive changes. At the time, she was unemployed and living with her son at Grace and Mercy, a safe home and caring support system for women in crisis. She had heard about YWC from another resident who had utilized YWC's Workforce Innovation and Opportunity Act services through the West Kentucky Workforce Board.

Haley had experience working in construction, but no postsecondary training. After discussing her future goals, she was determined eligible for Out-of-School Youth Services. YWC staff assisted Haley to map out a plan that included enrolling in Hopkinsville Community & Technical College to study Residential Construction. She began classes in January 10, 2023 and completed in April 27, 2023. She also began a paid-work experience with Frank Dudas Builders on February 22, 2023 and gained experience in home construction. She completed that experience on June 6, 2023.

Haley decided not to complete occupational skills training; instead she chose to go work. She has become employed at Comefri, Inc., a manufacturing facility in Hopkinsville. There she works as a forklift driver earning \$18.13 an hour.

### **COMMUNITY & ECONOMIC DEVELOPMENT**

### **OVER \$750K AWARDED TO MUHLENBERG COUNTY** AIRPORT HANGAR EXPANSION



Delta Regional Authority (DRA) is awarding over \$1.5 million in investments to three projects in Western Kentucky through the States' Economic Development Assistance Program (SEDAP), with Muhlenberg County being one of them.

Funding for this program was made available, in part, by the Bipartisan Infrastructure Law signed by President Biden, a key part of his Investing in America agenda to grow local economies from the middle out and bottom up and create more resilient and healthier communities across the country.

The Muhlenberg County Airport Hangar Expansion project in Greenville has been awarded more than \$759,000 as part of a multi-phase airport expansion that will support the Madisonville Community College Fixed Wing Aviation Program.

As one of DRA's main investment tools, SEDAP provides direct investments for basic public infrastructure, transportation infrastructure, business development with an emphasis on entrepreneurship, and workforce development. DRA coordinates directly with the Office of the Governor for the Commonwealth of Kentucky and the state's Local Development Districts for program funding implementation.

### RESOURCES FOR CYBERSECURITY

### DRINKING WATER STATE REVOLVING FUND (DWSRF) CALL FOR PROIECTS



Fall is here and marks the beginning of the annual Call for Projects. Over \$144 million is anticipated to be available from the Clean Water State Revolving Fund (CWSRF) and **Drinking Water State** 

Revolving Fund (DWSRF) for projects submitted during the Call for Projects. The CWSRF and DWSRF Call for Projects Will Be Open from September 26, 2023 to December 15, 2023 If you have a drinking water or clean water project and are seeking funding during the 2025 state fiscal year (July 1, 2024 through June 30, 2025), this is the time to submit for funding consideration. These are competitive programs. To qualify for a low interest loan, your project must be ranked and listed on the 2025 Project Priority List developed collaboratively through the Division of Water (DOW).

### **CEDS DRAFT UPDATE**

The Pennyrile Comprehensive Economic Development Strategy (CEDS) is the result of a local planning process designed to guide the economic growth in the Pennyrile region. The CEDS process helps create jobs, foster more stable and diversified economies, and improve living conditions. It provides a mechanism for coordinating the efforts of individuals, organizations, local governments, and private industries concerned with economic development.

The Pennyrile CEDS is required to be updated annually in order for local governments to qualify for Economic Development Administration (EDA) assistance under its public works, economic adjustment, and other planning programs. The CEDS is also a prerequisite for designation by EDA as an Economic Development District (EDD).
