Historically, transportation services for the elderly have been limited to remaining within an individual's county of residence, but this is challenging for senior citizens who need to access medical care outside of their county of residence. In February 2023, an Out of County Transportation Pilot was implemented, with American Rescue Plan Act funds, in Livingston County and Crittenden County. The service provides medical transportation for senior citizens to travel no more than 2 counties outside of their county of residence for medical appointments. There is a \$2.00 fee per one-way trip and the service must be scheduled at least 24 hours in advance. Since implementation, 21 senior citizens have been served with 3,180 miles of medical transportation. With the success of the service and the need in other counties within the Pennyrile Region, we're very happy to announce the expansion of Out of County Transportation Pilot to Lyon County and Todd County starting January 1, 2024. Family Caregiver Program



1 in 4 adults in Kentucky serve as a caregiver to a friend or family member and over half of those caregivers have provided at least two years of care.

November was recognized as

National Family Caregiver Month and a time to recognize and honor caregivers across the country. I want to take a moment and say THANK YOU to all caregivers, past, present and future, across our region. Your commitment and service to care for your loved one should not go unnoticed or unappreciated! It has been said that caregivers are the bedrock of healthcare for families – so thank you for being a caregiver!

The National Family Caregiver Program offers several services to benefit caregivers who may need extra support. The respite program helps provide a break

for caregivers while assuring their loved one is still being cared for. The supplemental program helps purchase needed items, such as assistive devices or incontinence supplies, to assist the care recipient in their everyday life. There is also a program for Grandparents Raising Grandchildren to help purchase needed items for the grandchild. We recognize that caregiving is a large task, the NFCSP program offers monthly support groups for Alzheimer's Caregivers and Grandparent Caregivers to provide an opportunity for caregivers to share their experiences as a caregiver and receive training designed to help caregivers.

Kentucky Veterans Directed Care

The Veterans Directed Care Program (VDC) is a program that provides veterans with opportunities to self -direct their long-term services and supports (LTSS) and continue living independently at home. Individuals enrolled in the KY VDC Program can select the services they need to main or increase independence, hire the employee they wish to hire to provide the care, and are actively involved in the entire process of developing their individualized plan of care. The KY VDC Program can aid with such tasks but not limited to, bathing, grooming, meal preparation, transportation to medical appointments, among other daily activities. Pennyrile has begun working with ACL and the Lewin Group to serve as a Super Hub and expand VDC services across several states. Pennyrile AAAIL currently serves as the HUB and manages two Spokes (AAAIL's) within the state of Kentucky, and four within the state of Tennessee. Through Pennyrile's contracts with the two VAMCs, this is a potential resource to approved veterans in 67 counties within Kentucky and Tennessee. Participant Directed Services

Pennyrile AAAIL currently offers both options of the Home and Community Based Waiver which consist of the Participant Directed Services (PDS) option as well as the Traditional option. Both programs are a potential resource for individuals with any form of disability including physical, cognitive, and developmental and require considerable assistance with ADL's & IADL's daily. Both programs help the client receive the care he/she requires in their own home and help prevent or prolong a client from being institutionalized. Department for Medicaid Services (DMS) has extended Appendix K polices while the program is under redesign for policy improvements with the Center for Medicaid Services (CMS). For the first time since its implementation of the HCB Waivers (2006/2007), the state of Kentucky had to implement a waitlist due to running out of slots. Since then, additional slots have been added with the HCB Programs, but the pace of growth continues to grow rapidly. News in Health - Wise Choices

Take Care of Injured Skin

- * **Keep open wounds clean**. Washing thoroughly with soap and clean water reduces the potential for infection.
- * Remove jewelry or clothing that could further irritate the wound.
- * Apply a bandage. Keeping the wound clean and protected reduces the chance of infection. Don't cover wounds that can't be cleaned, like bites or deep punctures, and see a health care provider.
- * Check the wound every 24 hours for signs of infection.

 These include redness, swelling, or oozing. See a health care provider if your wound becomes infected.
- * Seek immediate medical care if you have fever, increasing pain, shortness of breath, fast heart rate, confusion, or disorientation.

MEDICARE BENEFICIARIES!

If you are currently having \$164.90 taken out of your Social Security check each month for your Part B monthly premium, and you are low income, there is a program that may be able to assist you with that premium cost! If your income is under \$1,660/single or \$2,239/married and your resources/assets are under \$9,090/single or \$13,630/married then you may qualify to receive assistance through the state through one of the Medicare Savings Programs. These programs may help pay for your Part B premiums and *potentially* assist in also paying for Part A premiums, deductibles, coinsurance, and copayments, depending on your income level.
