Bridging the Gap Pilot

The Pennyrile Area Development District was selected to participate in a pilot program called Bridging the Gap. The pilot program is a collaboration among the Office of Dementia Services and three Area Development Districts across the state. The goal of the pilot is to empower lives with Dementia Care Specialists who will assist the person living with dementia and their caregiver. The Dementia Care Specialists will provide dementia education and training opportunities in our region while additionally serving the program participants with respite care and assistive devices to help maintain in their own home. Out of County Transportation Pilot

An Out of County Transportation Pilot is available in Livingston County, Crittenden County, Lyon County & Todd County. The service provides medical transportation for senior citizens to travel no more than 2 counties outside of their county of residence for medical appointments. There is a \$2.00 fee per one-way trip and the service must be scheduled at least 24 hours in advance. Since implementation, over 4,900 miles of medical transportation has been provided. If you live in Livingston County, Crittenden County, Lyon County or Todd County and need medical transportation, we encourage you to access it through this Out of County Transportation Pilot. Family Caregiver Program



The National Family Caregiver Program has purchased a lifetime Honor My Decisions advanced care plan account for caregivers and their loved ones! This service is available to anyone interested in the program. Honor My Decisions is a secure online software that makes it easy for you to create and share a comprehensive digital advanced care plan. Ombudsman Corner—Discharge to a Homeless Shelter

One of the important things Long Term Care Ombudsman assist with, is our fight to keep residents in their home. Every resident in long term care has the right to appeal any notice of discharge from their home. Nursing Facilities sometimes struggle to provide care for residents with dementia or other complex care issues, especially behaviors. Some facilities try to discharge residents by violating that right.

Our program received a call that the family was being told they had to come get the resident by the end of the

day or they were discharging to a homeless shelter. This is a complete violation of resident's rights and is an inappropriate discharge. We called and spoke with the administrator discussing the rights of the resident to a 30-day written notice of discharge. The facility agreed not to discharge and gave the resident a 30-day written notice of discharge.



We assisted the resident, at their request, and wrote and submitted the appeal. A few days later we were granted a final order instructing the facility not to discharge because the notice was deficient and violated the resident's rights.

Sadly, our program commonly addresses complaints about improper discharges. If you or your loved one have been issued a discharge notice from a nursing facility, please call us at 270-886-9484 to learn how to appeal. Don't give up your rights to stay in your home!

ARPA Funds Purchase Ramps

The National Family Caregiver Program was recently able to utilize ARPA funding to purchase metal ramps for clients in our region. These ramps replaced previous wooden ramps with holes in them or added ramps to homes that did not previously have one. These have been a great benefit to the caregiver when getting their loved one out of the home for medical appointments and provides peace of mind in the event of an emergency situation. Kentucky Veterans Directed Care Program



The Veterans Directed Care Program (VDC) is a program that provides veterans with opportunities to self-direct their long-term services and supports and continue living independently at home. Individuals enrolled in the KY VDC Program can select the services they need to maintain or increase independence, hire the employee they wish to hire to provide the care, and are actively involved in the entire process of developing their individualized plan of

care. The KY VDC Program can aid with such tasks but not limited to, bathing, grooming, meal preparation, transportation to medical appointments, among other daily activities. Pennyrile has begun working with ACL and the Lewin Group to serve as a Super Hub and expand VDC services across several states. Pennyrile AAAIL currently serves as the HUB and manages two Spokes (AAAIL's) within the state of Kentucky, and four within the state of Tennessee. Through Pennyrile's contracts with the two VAMCs, this is a potential resource to approved veterans in 67 counties within Kentucky and Tennessee. Participant Directed Services

Pennyrile AAAIL currently offers both options of the Home and Community Based Waiver which consist of the Participant Directed Services (PDS) option as well as the Traditional option. Both programs are a potential resource for individuals with any form of disability including physical, cognitive, and developmental and require considerable assistance with daily ADL's & IADL's daily. Both programs help the client receive the care he/she requires in their own home and help prevent or prolong a client from being institutionalized. Department for Medicaid Services (DMS) has extended Appendix K polices while the program is under redesign for policy improvements with the Center for Medicaid Services (CMS). For the first time since its implementation of the HCB Waivers, the state of Kentucky had to implement a waitlist due to running out of slots. Since then, additional slots have been added with the HCB Programs, but the pace of growth continues to grow rapidly. Kentucky Family Caregiver Program

The Kentucky Family Caregiver Program (KFCP) provides resources and support to grandparents raising grandchildren in the Pennyrile region. The Kentucky Caregiver program does have a low-income requirement and an age maximum of 18 for the grandchildren served. There are over 51,000 grandparents raising grandchildren in the state of Kentucky. The KFCP can provide assistance up to \$500 per grandchild per fiscal year to assist with items such as clothing, personal care items, school supplies, and furniture for the grandchild. This program also assists grandparents that are looking for help with educational needs, legal services, medical/dental services, and/or respite for the

grandchild. MEDICARE BENEFICIARIES!

If you are currently having \$164.90 taken out of your Social Security check each month for your Part B monthly premium, and you are low income, there is a program that may be able to assist you with that premium cost! If your income is under \$1,660/single or \$2,239/married and your resources/assets are under \$9,090/single or \$13,630/married then you may qualify to receive assistance through the state through one of the Medicare Savings Programs. These programs may help pay for your Part B premiums and *potentially* assist in also paying for Part A premiums, deductibles, coinsurance, and copayments, depending on your income level.
