**RESOLUTION 2025- 18**

**ADOPTION OF A RESOLUTION OF THE CHRISTIAN COUNTY  
FISCAL COURT REGARDING THE STRATEGIC PLANNING  
GOALS FOR THE COUNTY FOR PROJECTS AND FUNDING  
NEEDS FOR THE YEAR 2026 AND BEYOND.**

**WHEREAS**, the Christian County Fiscal Court recognizes the importance of establishing legislative priorities to guide the development and success of Christian County for the upcoming year; and

**WHEREAS**, the Christian Fiscal Court has identified a set of legislative priorities deemed as needed for the advancement and development of Christian County;

**NOW, THEREFORE, Be It Resolved** by the Christian Fiscal Court that the following legislative priorities shall be pursued throughout 2026 and beyond:


- 1) **Commerce Park II Investment:** To explore options to acquire Commerce Park II through appropriate channels to enhance the county's competitiveness in recruiting major economic-based manufacturers to the county.
- 2) **KY 115 Improvements (Anderson Lane to I-24):** To assist with upgrades to support new industrial and retail growth related to Commerce Park II and within Oak Grove. This initiative will include looking for additional funding sources including Kentucky Product Development Initiative (KPDII) and Kentucky Economic Development Finance Authority (KEDFA) and enhance safety and improve the increased traffic flow patterns along the KY 115 corridor for multiple projects.
- 3) **Oak Grove Water Project Investment:** To support Oak Grove with water infrastructure expansion to support rapid growth being seen in Oak Grove and source potential funding sources for same.
- 4) **Christian County Water District Phase 10:** To source funding opportunities to support system upgrades to expand capacity, modernize current infrastructure, and support overall industrial development in the county.
- 5) **Renovation of Historic County Buildings:** To engage in the development of an architectural master plan to modernize county facilities and historic buildings (i.e., modernization while preserving historic structures).
- 6) **Western Hills Municipal Golf Course:** To look for funding sources to assist with upgrading facilities at Christian County's only public golf course to modernize and attract participation.
- 7) **Alhambra Theatre Upgrades:** To pursue necessary upgrades to infrastructure at our historic Alhambra Theatre including fire curtain replacement, sprinkler system repairs, and HVAC modernization.

**BE IT FURTHER RESOLVED** that the Christian County Fiscal Court commits to the pursuit of these legislative priorities to ensure the realization of these objectives for the benefit and prosperity of Christian County.

Adopted at a regular meeting of Christian Fiscal Court held on December 23rd, 2025, a quorum present and voting.
