Fees

- \$700.00 USD for members.

- Attendees may include a guest for an additional \$150.00 USD. Guests are invited to the opening reception and all meals.

Group Payments: Group payments may be made by check. Please provide the names of all the attendees and guests when submitting payment.

CLE: The registration fee includes CLE applications and processing. Attendees can expect to receive approximately 8 hours of CLE credit (depending on the jurisdiction).

Non-Members: Non-members are welcome to attend the seminars and social events associated with the Annual Meeting but are not invited to the business meeting.

Fee Waiver: The AFBC is committed to making its Annual Meeting accessible. If an attorney is experiencing a financial hardship, that attorney may make application to the Executive Committee to have the meeting fee waived for that year. Refunds: The AFBC will refund 100% of fees for any cancellation request received on or before May 15, 2026. For any cancellation request received between May 16th and May 31st, the AFBC will refund the registration fee(s) minus any processing fees and, if applicable, meeting costs incurred related to the registration. No refunds will be made after May 31st.

Lodging

Hotel reservations are not included with the registration. The AFBC has secured a limited number of rooms at the Coeur d'Alene Resort at a discounted pre-tax and fees rate of \$385.00 USD. Reserve your room at the link provided on www.afbconline.org or by calling **888-965-6542** (mention the Association of Fraternal Benefit Council (AFBC) to ensure you receive the group rate). Subject to availability, the AFBC group rate is valid three days pre-arrival and three days post group departure. Note, if you wish to extend your stay at the group rate (subject to availability) beyond the event dates, you must call to make your reservation. Reservations must be received by Friday, May 22, 2026, to receive the group rate. Check in is at 4pm and check out is at 11am. The hotel may charge fees for early departures or cancellations. Parking is \$22 USD per 24 hour period. Valet services are also offered at \$27 USD per 24 hour period.

Airport Transportation

The Coeur d'Alene Resort offers transportation to and from the Spokane International Airport. Standard Service Van transportation is available for \$45 each way per guest. 48-hour notice is required for all transportation requests or cancellations.
